

Capitalism, you will be told, has invented a way for everybody to share in the wealth of this great nation. By investing your savings in the stock market, even you Most economics teachers (together with

can play a modest role in the country's great industrial enterprises. Stock holdings, however small, allow you along with

however small, allow you along with millions of other ordinary citizens to influence corporate decision making and to share in the profits of the great companies.

But the vast majority of working people know, without too much deliberation, that the stock market is not their cup of tea.

Money they are able to set aside has a crucial value for most working people and often a specific object.

The stock market is a risky venture at

best for small investors and is a full-time occupation for many of those parasites who live off it. In fact, though most workers wouldn't put it this way, perhaps, stocks and stock dividends are among the clearest examples of how workers are robbed of the full value of their labor.

The profits derived from stock holdings are part of what is called surplus value, that value which the workers produce beyond what he or she is paid in wages. Through the

wonders of monopoly capitalism, that value is siphoned off into the coffers of those who already have more than they need.

Let's say that today's Rockefellers did not own the Chase Manhattan Bank. Let's say they didn't have Exxon, Mobil, Continental, Marathon, Cities Service, Standard of Ohio, Standard of Indiana—and California. Let's say they didn't control AT&T, Con Edison, Pan American Airlines, Eastern, National, etc., along with 20 or 30 utility companies and pieces of Chrysler, Ford, Firestone, and Goodyear.

Let's say they just had only that billion dollars and didn't know any more about

Wall Street or have any more influence in the U.S. government than you or me. If they only had a billion to invest, and even assuming they were perfectly helpless idiots, they could put it in the bank at 6 percent interest and draw \$60 million a year just for leaving it there.

With that \$60 million, they could live austerely on \$9 million a year. Then they could hire \$1 million worth of lawyers to keep the tax down on the other \$50 million. And even a legal dunce could keep the tax under \$10 million. So they would have \$40 million left each year to put back into the bank.

And just think, they could get all that without robbing a single Arab, or

superexploiting a single South American, or shooting a single Black African!



### capitalist suff slumpflation ardship

NEW YORK, April 24—The cost of living for the first 3 months of 1974 rose at the annual rate of 10.8 percent a year, with consumer prices going up in March at an annual rate of 13.2 percent. This is the fastest rate of increase in 23 years.

At the same time, industrial production dropped at a yearly rate of 5.8 percent, the worst drop in 16 years.

The combined inflation and industrial stagnation, called "slumpflation" by ruling class economists, was the worst it has been since World War II saved the capitalist system from the 1930s depression.

Prices have continued to rise throughout 3 years of "controls." As if that weren't bad enough, worse is predicted for the future when the inadequate controls of Phase 4 are phased out. In spite of promises of "restraint" on the part of big business, costs for such items as medical care, housing, and canned goods can be expected to take off when remaining controls are lifted on April 30. April 30.

AGGRAVATES CRISIS

A major cause of the hardships workers are being forced to bear is the enormous \$95-billion-plus military budget. This money is put into the economy to buy socially useless weapons, aircraft, missiles, etc. This increases the supply of printed money while the supply of things to buy is actually decreased, due to the gigantic waste of steel, rubber, oil, and other items.

Think of how many essential items are wasted to build destructive weapons, keep enormous planes and ships in constant use, and maintain millions of troops and civilian employees of the military—who, although they work, do not contribute anything useful to the economy. The workers must pay for this criminal waste through high taxes, through money that actually buys less and less real goods, and through shortages.

This higher rate of interest shows itself in higher mortgage rates, higher' rents, higher rates for all kinds of consumer loans. It is through this process that the big banks, such as BankAmerica and the Rockefellerowned Chase Manhattan Bank, actually control almost all big business in this country and profit even when a company is supposedly going "broke."

Big businesses such as the Penn Central Railroad, Lockheed Aircraft, and lately New York's Consolidated Edison (gas and electric) then demand that the workers, through their taxes, bail them out through subsidies, government loans, and tax breaks (beyond the usual dodges of the corporations). Or they even insist that the government "buy" them, as in the case of mass-transit systems throughout the

PRODUCTION OFF

The rising prices of almost all goods and services are also forcing workers and middle class consumers to buy less food, clothing, and other necessities, as well as put off or give up buying "luxuries" such as cars and houses. The rising cost of raw materials also causes a drop in production, as does the higher cost of borrowing to build plants, put in new machinery, and install new equipment

The rate of delinquent and bad debts has also gone up 20 percent from the end of 1973, as more and more workers find themselves unable to pay off debts because of layoffs, cutbacks in working hours, and rising prices for food, clothing, transportation, fuel, and

All this, combined with shortages of fuel, has caused a drop in production of all kinds of consumer goods, a slowdown in housing construction, and more hardships for poor and working people.

In socialist countries, such as China, Cuba, and the Soviet Union, where production is planned according to the needs of the people, prices and taxes are actually going down while production of food, clothing, and all the things people need rise

daily.

Only when the poor and working people here end the chaos of capitalism, with its inflation, unemployment, and shortages, will we truly be able to solve these

Some may shed sad tears over this great decline in profits for the Rockefellers. But we must point out that the same Rockefeller family controls, and is far the biggest stockholder in, the Exxon Oil Company (which provides gasoline for Chrysler cars), which netted a clear profit of over \$1 billion after taxes last year.

That's about 625 times as much as \$1.6

### through jobless Motor worke

DETROIT, April 28—In many parts of
Detroit these days, unemployed workers
can be seen lined up for blocks, waiting up to
4 hours for their checks. the victims in the wave of layoffs, since GLS only began to hire women last year, under great pressure.

In Detroit, many Black auto workers had only been hired in the last few years, due to concessions like "training programs," created because of the fear that rocked the ruling class after the great upheavals in the Black community in the late 1960s. These are the workers who bear the brunt of the layoffs.

Michigan, the heart of the auto industry, now has the highest unemployment rate in the U.S., underestimated by the government

at 10.9 percent.

Flint, Michigan, a company town where two-thirds of the workforce is employed by General Motors, has been hit by a virtual depression, with one out of every six workers laid off.

Despite layoffs which have reached the proportions of a disaster, the auto industry claims the hardships they have created are minimal because of the United Auto Workers' Supplemental Unemployment Benefits (SUB) program. FROM UNEMPLOYMENT SUBSISTENCE
TO WELFARE
Along with the UAW and USW members
who don't qualify for SUB benefits, there are
thousands of unemployed workers who have
no SUB plans at all. Michigan's unem-

no SUB plans at all. Michigan's unemployment compensation allows a single worker as little as \$16 per week, and even a large family is not entitled to more than \$92

# SUB HELPS WORKERS THROUGH CRISIS, BUT. . .

The SUB plan, which is funded by the company and handled by the union, provides a supplement to the unemployment check so that eligible auto workers get 95 percent of 40 hours' take home pay, minus \$7.50. In the steel industry, SUB makes up 85-90 percent of the average 40-hour take home pay.

But auto workers must have a minimum of 1-year seniority to qualify for SUB pay, while steel workers need 2 years. Auto workers need 2 years to qualify for a full 52 weeks of SUB pay. Those who have exhausted their unemployment benefits, or who were ineligible in the first place, face an even more desperate situation. Since October 1973, when the Big Three auto bosses first began the wave of energy crisis layoffs, at least 5,000 have been added to the state's

## .. IS IT ENOUGH?

Altogether, more than 410,000 Michigan workers are out of jobs, yet only around 100,000 are eligible for SUB pay. Out of 27,000 on an indefinite layoff from GM, nearly 15,000 don't qualify for SUB pay, and 1,100 can't even collect unemployment compensation of any kind!

Those workers who are collecting SUB pay aren't exactly living easy, either. Social security and income taxes are deducted from a check that already is based on wages after taxes. And in an industry where many normally work 60 or even 84 hours a week, SUB pay based on 40 hours is a drastic pay cut.

THIRD WORLD AND WOMEN

WORKERS HIT HARDEST

It is especially Third World and women auto and steel workers who are ineligible for SUB pay, because they have only recently been hired. For example, at Great Lakes Steel, near Detroit, they are the majority of


welfare rolls.

During January alone, over 2,000 went on welfare, and over half were laid-off HOW ARE THE AUTO BOSSES 'SACRIFICING'?

Net sales and income records were set by GM during 1973 when the company's profits soared to nearly \$3 billion on sales of \$38.5 billion. Richard Gerstenberg, Chairman of General Motors, received the biggest salary of any executive in the country—\$923,000! He got a "noninflationary" 5.5 percent raise last year of \$48,000!

SUB benefits exist only because the auto and steel workers fought for them. The bosses hope by this measure to take the bite out of their periodic layoffs, just as the state thought it wise at this time to extend unemployment benefits from 26 to 39 weeks.

SUB and unemployment benefits must be extended and improved. But that won't get at the source of the problem, the profit system which makes jobs expendable. The only real solution is jobs for all.

# mayor ce unleash racist

SAN FRANCISCO, May 1—Under the code words "Operation Zebra," police here have initiated a campaign of unbridled racism and repression in the Black community. Using clearly fascistic tactics of "stop-and-search," intimidation, and harassment, local and state authorities are attempting to create a climate of fear and

Beginning on April 17, the police began making massive invasions into the Black community, using as an excuse a series of unsolved murders dating back to last

November. All the victims have been white, they say, and the cops claim to have a composite drawing of the suspect. This drawing is so vague, however, that it has given the cops the green light to stop virtually any Black man on the streets.

As of this writing, Mayor Alioto has announced what appears to be a full-scale escalation of the original attempts at racist hysteria. The authorities are now claiming that the murders were part of a pattern involving 80 white victims starting from 1971, and that there isn't just one killer, but

what this "pattern" really consists of isn't explained. Aren't there any unsolved murders of Black people over this period? Why not include them in the "series" of murders?—except that then the "pattern" concocted by the racist authorities is

broken.

The operation was dubbed "Zebra" supposedly because the police radio communications are done over the "Z" radio band, but the racist overtones are obvious.

Taking tactics from apartheid South Africa, police have stopped, questioned, harassed, and issued identity cards to over 700 Blacks. This reporter spoke to one man who was stopped five times in Oakland! (The search is supposedly only in San Francisco.) Police have drawn on reserve units and are riding around with shotguns in their cars. There have been arrests every

IMMEDIATE RESPONSE


These actions prompted outrage and protest from within the community. Such groups as the Officers for Justice (a group of Black San Francisco police), the NAACP,

the Black Panther Party, and many church groups issued immediate statements opposing it. Legal actions have been taken by the NAACP, the ACLU, and the Mexican-American Legal Defense Fund.

On Monday, April 22, nearly 1,000 Black, Latino, and white protesters gathered at City Hall to display their outrage. When Mayor Alioto appeared during the middle of

MAY 2—Striking at dawn in true gestapo fashion, 100 San Francisco cops arrested 7 Black men on charges of committing the so-called "Zebra" murders yesterday. Three of the men are alleged to be Muslims and several are former inmates in California's infamous prison system.

With indecent haste, Mayor Alioto rushed to hold a press conference just a few hours after the arrests to state that he was "satisfied that we have the men." He then proceeded to weave the fantastic tale of a supposed organization called the "Death Angels," which he asserted is responsible for over 80 deaths in California and many more nationwide. Without explaining how he got such "information," and with no concern that he was convicting the defendants without a trial, Alioto said that the "Death Angels" were directed by an unnamed man in the Midwest who rewarded members for decapitating or chopping up their victim.

(The allegations were so fantastic and sweeping that even California Attorney General Evelle Voinger backed away from

several murder cases. The manhunt became so widespread that any Black man walking on the streets could be picked up and harassed for no reason at all.

When the Black community, along with Chicano and white supporters, began to mobilize against this onslaught. Alioto decided to change his tactics. With the arrests and bogus scare stories of plots against whites he obviously hopes to whip up a hysteria against the Black people and prove how right he was in beginning the campaign in the first place.

(Alioto, by the way, is making a bid for the Democratic nomination for Governor of California and is said to be a poor third in the race. His campaign clearly needs an issue to get it off the ground.)

This crude racist frameup has all too many ugly precedents. The wild stories of plots against white people sound very similar to the so-called Blood Brothers case in Harlem in 1965. At that time, 6 young men were arrested for supposedly plotting to kill

were arrested for supposedly plotting to kill white people. The story was exploded in the newspapers with blood-curdling details. The young men were railroaded to prison before it was revealed that the allegations in the papers were pure fiction. Yet four of the youths (who came to be known as the Harlem 4) spent 8 years in prison before

Mayor Alioto appeared during the middle of the picketing, the demonstrators descended on him. His security guards had to push him into his car as the outraged people chased him halfway around the block, surrounded his car, chanted, and pounded on the hood. Even some of the moderate Black politicians in the Democratic Party whom Alioto was able to get to endorse his actions have deserted him and expressed their

What is going on now in this city is in reality a test to see whether the population can be made to accept faseist tactics such as large manhunts and the issuance of passes to Black people. This is part and parcel of the general atmosphere of intense racism that has been unleashed here by the forces of extreme reaction. For example:

-Within the past month alone four children have been murdered in Oakland and Berkeley by policemen still on the force. The Oakland police are infamous throughout the community.

-The offices of the Black Panther Party were raiged in Oakland in a predawn attack on April 16. Police arrested 14 people and said they confiscated drugs and

and said they confiscated drugs and weapons. Thirty hours later the 14 were freed; all charges were dropped for lack of evidence

Muslim temple and In Sacramento, cops attacked a Black m temple and arrested four Muslims

Vietnam veterans were arrested in Chicago last year amid tales that they were the De Mau Mau brothers, bent on killing white people. Convicted by a wild newspaper campaign, they remain in prison today, except for one, who died "mysteriously" in jail before he even got a trial.

After Alioto's racist remarks, it is clear that the 7 men arrested in San Francisco not only could not get a fair trial, but should be released immediately. In this case, no trial would be the only fair trial!





The Attica Brigade had called for a march following the rally at the Capitol. YAWF decided to join and support the march, as we would support any expression of progressive, militant opposition to Nixon.

When the front of the march reached the Justice Department building, the YAWF contingent was still on the opposite side of Constitution Avenue. Hundreds more behind us were still rounding the corner or coming through the opening in a fenced-in lot. When the front half of the march, predominantly Attica Brigade and RU, was blocked by the cops, they turned and started running back across the avenue. The cops followed on scooter and foot.

The impact caused by those in the front of the march turning and running into the people packed behind them made a calm and orderly retreat impossible. This ignited a panic and stampede in which people were trampled and crushed up against and under

the fence. The pigs also seized the op-portunity to club, pick off, and bust those left stranded.



Ridiculously, the Attica Brigade and RU asserted that this "blocked their" retreat. In line with some of the elementary rules of street action, YAWF did its best to urge people to be calm and prevent further panic. And, unlike the RU policy of dropping their banners during an attack, YAWF

It was upon returning to the Capitol rally sight that an RU spokesperson went to the microphone and made a scurrilous denunciation of Youth Against War & Fascism in an attempt to cover up their own failures. And it was during that slanderous speech that the Attica Brigade and RU declared "war on YAWF," as their members in the audience chanted "pigs," "Trotscum," "We'll get you with ice picks," and physically jumped several YAWF members, but retreated quickly after YAWF defended itself

Although YAWF answered them immediately and effectively from the speakers' stand at the rally itself, we are addressing this open letter to the movement for the benefit of those not present at the action who could not see for themselves what really happened.

The hooliganism, name calling, and slanders employed by RU-Attica Brigade leaders against YAWF at that demonstration had been building for some time. They were only the culmination of a growing trend in those organizations to substitute, in place of political discussion, a policy of outright falsification and physical violence against revolutionaries in the movement, particularly YAWF.

The movement needs militant struggle and aggressive tactics; that is certain—but



against whom? What must the awakened but uncommitted sections of the progressive masses think when they see a bunch of radicals carry out a struggle against another tendency with greater vehemence and passion than they exhibit toward the class enemy?

OUR ATTITUDE TOWARD OPPONENTS
Our attitude toward the question of how to deal with opponent tendencies is this: It is the ruling class that must be physically overthrown, not misguided or reformist tendencies in the workers' movement. They will be defeated politically by that tendency which proves it best understands how to overthrow the ruling class.

While the Attica Brigade and RU leaders have made their bizarre declaration of war on our organization, we will continue to carry on and build our war against

capitalism, imperialism, and racism, while defending ourselves against any who seek to thwart us in that effort.

The present period of relative calm in the face of rapidly deepening economic crisis may create frustration and impatience among some in the movement. But to direct that frustration into a bombastic attack on other left tendencies, as RU has done, solves nothing and is a cowardly abandonment of the real struggle.

Instead, all honest revolutionaries must continually seek to find a path to the masses of workers and oppressed, whose conditions of life are rapidly deteriorating and who will be looking for uncompromising leaders in their fight for survival.

It is in this arena—where the victors will be those who show the greatest determination in fighting the racist, militarist U.S. ruling class—that YAWF challenges all corners.

WASHINGTON, D.C., April 27—Ten thousand people marched here today in a demonstration called by the National Campaign to Impeach Nixon.

The crowd was predominantly young—for many it was their first demonstration. Among the marchers were a few small trade union delegations (UAW, Farm Workers, and AFSCME).

Many people carried homemade signs demanding Nixon's ouster and denouncing his racism, his attacks on poor people through budget cuts and impoundment of funds, his war crimes in Indochina, and his collusion with the oil barons during the energy crisis.

Although a majority of the slogans centered on Nixon himself ("Impeach Nixon" and the Revolutionary Union's (RU) "Throw the bum out"), Youth Against War & Fascism's (YAWF) placards against capitalism and imperialism in general ("Indict Nixon and the whole system") were very popular with the demonstrators. The demonstrators left the Washington Monument area shortly after hoon and marched down Constitution Avenue to the mall area near the Capitol.

The main chants taken up by the marchers were initiated by the RU ("Throw the bum out") and YAWF ("Jail Nixon, jail Ford, Jail the rich and free the poor").

## ANGER AT INJUSTICE

The anger on peticularly evident as the hated "Justice" people's le's faces was par-y passed in front of partment. Above its

doors are inscribed the words, "The place of justice is a sacred place." Shouts of derision and hatred greeted this platitude and the hated building where the frameups of left organizations and the extermination campaign carried out against the Black Panther Party were plotted.

The rally itself was addressed, among others, by Delores Huerta of the National Farm Workers Union; Beulah Sanders, a Black woman long active in the struggle of poor people and those on welfare; Dave Dellinger, a defendant in the Chicago conspiracy frameup aimed at the antiwar movement; and Herbert X Blyden, one of the Attica Brothers.

Huerta and Blyden both stressed the importance of the struggle against racism. Huerta stated that it was "this cancer of racism" which greatly aided Nixon in his 1972 reelection to the presidency.

Blyden called for support for the Attica prisoners, who survived the 1971 genocidal assault that took 43 lives only to face heavy charges stemming from the uprising. Some of the defendants are charged with murder, but not one of the cops who mowed down 43 unarmed men—nor Rockefeller himself, who ordered the massacre—has been indicted. Blyden condemned the racist harassment being carried out by the police, under the code name of "Operation Zebra," against the Black people of San Francisco.

NEW YORK, May 2—On Sunday, April 28, former Attorney General John Mitchell and former Commerce Secretary Maurice Stans beat charges of lying to a grand jury and blocking an investigation of close Nixon business associate Robert L. Vesco.

Although Mitchell and Stans are the only Watergate criminals who have gotten off free among the 27 so far brought to court, and both face another trial next September on charges of conspiracy and perjury, Nixon seized upon their acquittal to launch a counteroffensive aimed at rolling back the impeachment tidal wave which seems about to break over his guilty head.

they will—and not just because they will become the subjects of speculation and even ridicule—which they will—but because of the principle of confidentiality."

Apparently this "principle" was inoperative when Nixon bugged his offices and phones in the first place.

Of course, this self-serving nonsense has nothing to do with the reason Nixon fought to keep his conversations with the Watergate conspirators secret since the existence of the tapes was revealed last July.

they show that Nixon was a direct participant in the conspiracy.



Suborning perjury, which Nixon's carefully edited version of the tapes still clearly shows him doing, should not be hard to prove based on statements from his own mouth quoted above.

In light of the extremely damaging evidence against Nixon revealed in the transcripts just released (not to mention that he has obviously destroyed 11 tapes and refuses to let experts see the remaining 31, clearly implying they have been altered), the capitulatory attitude of the liberals following Nixon's speech provided a nauseating spectacle indeed.

Television commentators on all three networks followed up Nixon's phony speech with remarks about what a "good impression he made," and how "the tide seems to be turning after the Mitchell-Stans acquittal and the frank speech of the President tonight."

The next day's papers were not far behind. James Reston of The New York Times wrote, "It probably was the most powerful and effective political speech Mr. Nixon ever made. . . As seen by the televison audience, the President's main target, it was probably an effective and even brilliant performance. He has released enough to create 'reasonable doubt' and that may be decisive in the end."

Most other liberal media big shots (who Nixon complains are "hostile" to him) poured out praise for Nixon's speech.

Although they may be slightly hurt by the increase in oil prices, they are hurt far more by the continuing increase in the prices of wheat, fertilizers, steel, and many other commodities produced almost solely in the imperialist countries.

Since the European colonial powers first began dividing up the world over 4 centuries ago, the development and material progress of vast sections of the earth's peoples have been forcibly held back. Under the system of colonialism, the riches of Asia, Africa, and Latin America were drained off at gunpoint, enabling Western capitalism to advance materially while the colonies could barely maintain the levels previously achieved.

Then, beginning with the present century, came a qualitative leap in capitalist exploitation. Surplus capital in the hands of European and U.S. financial institutions cried out for labor and raw materials. The old colonial process of the simple extraction of goods—mostly agricultural products—from the subjugated lands gave way before a more voraciously productive and intensive form of labor exploitation: imperialism.

The export of capital to the once-colonized world created vast new industries; it brought "modern" adjuncts of production—electricity, roads, airports, mechanized agriculture, etc.—to countries that had been stifled from producing these things themselves. It created an industrial, and a rural, proletariat.

derdeveloped" countries know only too well, imperialism brought in capital and capital goods for one purpose only: to take out more than they brought in, to superexploit the rest of the world. as the people of the

The roads were built from the mills and plantations to the ports. The electricity was to run the installations of the Sun Oil Company and the United Fruit Company.

Only socialist revolutions have reversed this deadly trend in the poorer countries. Of all the countries where famine, disease, ignorance—and foreign oppression—were the rule, one in particular stands out as having remarkably conquered these seemingly hopeless problems.

That country is China. In the present atmosphere of detente, abundant evidence can be found even in the U.S. mass media to prove that China has reversed the trend toward starvation and poverty to be found in

other "underdeveloped" lands and is rapidly and consistently building a better life for its people through socialist planning.

## CHINA AT UN SESSION

in the world this way:

"The United States and the Soviet Union make up the First World. The developing countries in Asia, Africa, Latin America, and other regions make up the Third World.

The developed countries between the two make up the Second World."

China, he said, is part of the "Third World" because it is "developing."

OPPOSITES LUMPED TOGETHER
Unfortunately, there is not a shred of
Marxism in this whole concept. What does
"developing" mean? Are India or Pakistan
developing in the same way as Cuba or
China? What about fascist Chile? Or semifeudal Ethiopia?

To lump together all the countries which have historically been held back by colonialism and imperialism—without regard for their present social character—is to put the Saigon regime in the same bag with North Vietnam, and China with... Taiwan.

The Chinese leadership may be looking for common ground with many of these countries on some international questions, such as the world market price of raw materials, hoping to somewhat loosen the grip of the imperialists. But in so doing, they have dropped the basic Marxist lesson that classes are in conflict in all the capitalist countries, and that only the victory of the workers and poor can in the long run break the hold of imperialism on the resources and labor of the oppressed countries.

The Chinese speaker also reiterated his party's position that the Soviet Union, as a "social-imperialist" "superpower," exploits the "underdeveloped" just as much as does the U.S. He even said that "the superpower which flaunts the label of socialism is especially vicious."

### inflation world capitalist spurred **Famine** in India

"India as a whole, living closer to the line between survival and disaster, ends up being more severely affected by adverse world economic currents than almost any

# DDres

diagnosis of India's present political and economic crisis. While the analysis may be accurate, the Wall Street newspaper carefully conceals the identity of the economic culprits it calls "adverse world economic currents"—which when translated should read "global imperialism headed by U.S. imperialism."

During the past year, the most devastating effect on India of the capitalist world's energy crisis has been a severe drop in chemical fertilizer production. Without adequate stocks of fertilizers, total food production has decreased in India. has mainly been the result of huge price increases in imported oil and other fuels, combined with a steady deterioration in the prices obtained for India's exports. Add the huge debt repayments made by India to the World Bank and other imperialist banks, and it can be seen that India was forced into a rollback of its basic industrial and food production.

production.

But Washington and Wall Street have been trying to push the blame onto the oil-producing nations for the higher crude-oil prices charged to other poor nations. What the imperialist robber barons don't explain is that it is their international oil monopolies which have squeezed billions of dollars of profits from oil-producing nations and outright colonies. Moreover, the imperialist powers have always manipulated the prices of the poor and colonial nations' exports to the advantage of the imperialist nations and their monopolies.

In fact, India's foreign minister recently stated at the UN that he did not criticize OPEC (Organization of Oil-Producing Nations) for having raised crude-oil prices, but rather said that he was "glad that OPEC's action has revealed the inequities and the weaknesses of the international economic system in all its aspects." He

"I confess I have some difficulty in appreciating the justification for the enormous increase in the cost of our essential imports from developed countries."

At the same UN session, Egypt's petroleum minister blamed the Western imperialist nations for the world energy crisis. He said it is regarded as a "world disaster" when poor countries demand legitimate prices for their exports, but it is looked upon as normal trading when the industrial countries raise prices. He further

"When mountains of butter and other food products are heaped in some highly developed countries and left to rot, while people in Africa and Asia are starving—when such disasters occur no one comments."

Meantime, while the giant U.S. oil monopolies are declaring first-quarter 1974 profit increases of 100 percent, 150 percent, and even of 740 percent, India may be approaching another catastrophic famine. Out of its population of almost 600 million, more than 200 million still earn less than \$40 a year. India's per capita income is expected to drop for the third year in a row. And the malnourished. Food consumption is declining, while the population growth is 2.5 fore than 70 percent of literate.

A moderate bourgeois critic of the India Ghandi government, the Hindustan Times, stated recently:

"Not since independence has the country faced such a deep and all-pervasive crisis as it does today. There are visible signs of disintegration. The rot has spread so far and so deep that it will not be easy to restore credibility to the Government."

Contrary to imperialist propaganda, the political disintegration of India is no mere "unfortunate turn of history." Actually, in

assistance) carved out from the colonial Indian subcontinent (which had included Pakistan and Bangladesh) a country which was based on the oppression of the numerous Indian national minorities by a Hindu ruling class—the old British imperialist "divide-and-conquer" policy.

Massive rebellions over food shortages have just erupted in two Indian states—Gujarat and Bihar. Almost 100 people have been killed in the former and 30 killed in the latter. Large street demonstrations organized by student organizations did bring down the local state government in Gujarat, and the struggle against the federal (New Delhi) government still persists. The demand for autonomy and self-determination has also long been heard in the states of Kerala, Madras, Uttar Pradesh, Orissa, Jammu and Kashmir, Nagalańd, and West Bengal. Even the Wall Street Journal admits:

"India, more a continent than a country, remains divided by caste, class, language and a dozen other factors..."

The Indian bourgeoisie (largely Hindu), in its 27-year-old rule and dependence on Western imperialism, has failed to solve any of the basic economic problems of the superimpoverished Indian masses. And they know that China provides for the Indian masses a vital socialist example of the road toward eliminating famine and dire poverty.

The yoke of imperialism must be rooted out of the Indian subcontinent and the politically bankrupt and oppressive capitalist class in India must be overthrown. A socialist revolution is the only solution to the economic liberation of the Indian sub-

### weak spot in Wall St reveals mpire thiopian revolt another

NEW YORK, April 29—A regime that only a short time ago was one of the most stable allies of U.S. imperialism in Africa is now wracked by political and economic crisis and is facing a mass upheaval of revolutionary proportions.

Strategically located at the crossroads of the Middle East and the African continent, with outlets on the Red Sea through lits colony Eritrea, Ethiopia has long been a secure haven for the imperialist U.S.

Yet now, a new round of strikes by t government workers, bus drivers, railroad workers, and dock workers has hit the country. The workers have left their jobs to protest starvation wages, shortages, and towering inflation, and to demand greater political freedom.

Although the per capita income is only a bare \$65 a year, the rate of inflation has soared to nearly 10 times that of the U.S. The minimum wage for Ethiopian workers is low—rising to 75 cents a day from 50 cents only because of the militancy of recent strikes.

The unemployment rate in E steadily increasing, mainly du number of peasants forced off the foreclosures or because of fan peasants are in the cities looking to ng, mainly due to the ts forced off their land by because of famine. The e cities looking for work— Ethiopia is due to the

Shortages are everywhere; Ethiopians are forced to import most manufactured goods, since the country's industrial development has been retarded by the needs of the imperialist system for markets and for coffee, which is Ethiopia's largest cash crop.

Earlier strikes against these inhuman conditions took place throughout March and into April. The first general strike in Ethiopian history, in fact, occurred in March, paralyzing the major cities for 4 days and cutting the country off from the outside world. The upheaval was sparked by a revolt of rank-and-file soldiers who demanded higher pay and political freedom. This mutiny quickly spread to the rest of the population.

The strikes are only part of a mass upsurge that has taken place in response to the rapidly deteriorating living conditions in the country—the worst of which is a famine that hit the northern provinces last spring and even now leaves over 1,000 corpses a day.

Peasants in the southern provinces have begun to rise up against the widespread starvation that recently hit the south. The feudal landlord class pockets 80-90 percent of the peasants' harvest, leaving barely enough for them to survive. And now, with the famine, the landlords are stealing the peasants' land and livestock to offset their own economic woes. Left with nothing but the prospect of death from hunger, the peasants have responded by holding mass demonstrations and by burning down their farms. According to the Ethiopian Herald, the Selassie government has established a heavily armed emergency police force to suppress the peasant revolts.

ERITREAN LIBERATION STRUGGLE
Nowhere is the struggle against the
Selassie regime and its U.S. backers so
advanced as in the annexed colony of

peasant revolts

coupled with the tremendous upsurge inside Ethiopia itself are beginning to constitute a real danger to Selassie's feudal monarchy and the imperialist interests it serves. They deserve the support and solidarity of progressive people throughout the world, especially in those countries where the workers have taken power.

Yet, an item in the February 1974 Eritrean Review, published by the ELF, suggests that the People's Republic of China has offered heavy weaponry to the reactionary Ethiopian government on a free-of-charge basis. The weapons include tanks and fighter planes. (This was later confirmed by Eritrean Review article pointed out that the Chinese weapons would be used "to strike at the Eritrean revolution," and "to suppress the Ethiopian people who are exerting all that lies in their power to get rid of Haile Selassie's feudalist regime which is also a tool in the hands of imperialism and Zionism."

The justification for supporting Selassie's puppet government can be seen in an article which appeared in Peking Review just as Selassie himself was given a warm welcome to the People's Republic in 1971. The article said, "The Ethiopian government follows the nonaligned policy of peace and neutrality and opposes imperialist aggression against Asian and African countries, thus making useful contributions to the promotion of Afro-Asian unity against imperialism."

Could this by any stretch of the imagination be the case? Could Ethiopia under Haile Selassie—the same Selassie who sent troops to suppress the Eritrean liberation struggle, who has allowed the U.S. military free run of the Eritrean seacoast and Ethiopian airspace, who just



a vital for the U.S., both financially and militarily. Kagnew Base in Asmara is well known as a major strategic communications base for the U.S. imperialist military. What's more, the Eritrean seacoast provides convenient ports for the U.S. Seventh Fleet.

The People's Liberation Forces, the military arm of the Eritrean Liberation Front, has won significant victories in the struggle for self-determination. Only recently, Selassie was forced to declare martial law in Eritrean cities in a desperate attempt to curb the activities of the liberation forces. This followed a series of spectacular actions by the PLF, including a surprise attack on the headquarters of the Ethiopian Second Army Division, the sinking of an Ethiopian spy ship, and cutting the main highway that links Asmara with the principal port city of Eritrea. Currently, guerrilla forces control portions of the Eritrean countryside.

recently called in troops on the workers in his own country—could he possibly be characterized as "nonaligned"?

Not only is the Haile Selassie government completely in the service of the world capitalist class, but the very revolutionary upheaval going on in Ethiopia today is caused by the capitalist relations that so oppress the Ethiopian people.

The crisis that the Ethiopian workers and peasants are so wholeheartedly struggling against is part of a world capitalist crisis and is the same crisis facing U.S. imperialism, one manifested in losses in Vietnam, the devaluation of the dollar, and the recent energy shortages.

It is a crisis being felt strongest in countries are always the weakest links in the world capitalist chain. Not only do the people suffer from the greed of the imperialists, who bleed the country of its wealth, but they are also brutally suppressed by the imperialists' puppet regime. It should be no wonder, then, that with the increase of suffering and poverty the Ethiopian and Eritrean masses- are rising up in rebellion.

All eyes were on Portugal this May Day, as the people poured into the streets by the millions to celebrate the downfall of the fascist Caetano regime. For the first time in at least 46 years, the workers of Portugal were able to celebrate the international workers' holiday.

As though out of the air, a mass-based left movement of socialists and communists has materialized, clear testimony to the failure of the fascist regime to break the spirit and solidarity of the working class. Reports from Portugal—of crowds burning the cars of the hated secret police, of mass demonstrations everywhere, even on the tiny island of Madeira, of actions by the masses to oust the fascists entrenched in every social institution—point to a genuine revolutionary situation in the making.

A 'POLITE' COUP

The military junta headed by General Antonio de Spinola, evidently surprised by the vehemence of the mass uprising, is maintaining a low profile in the streets while consolidating its powers. The junta took over in an almost bloodless coup when Premier Caetano relinquished his post after a 'polite' talk with the general. Caetano and his Cabinet were jetted to the tourist island of Madeira the next morning, where they are being comfortably detained in the safety of a castle surrounded by troops.

It is obvious that, faced with rising rebellion at home and an unwinnable war in its African colonies, the Portuguese fascist regime had been tottering for some time. An attempted coup this March, after General Spinola had been relieved of his post for publishing a book admitting Portugal's inability to win the war, narrowly missed its mark. That was followed by the bombing of a troop ship about to leave for Africa—the work of a Marxist guerrilla group.

Over 40 percent of the nation's budget has been poured into the fascist regime's vain attempts to subjugate the peoples of Mozambique, Angola, and Guinea-Bissau. Only the continued handouts of U.S. and NATO money kept the country from complete bankruptcy.

SPINOLA OPPOSES FREEDOM
FOR COLONIES
But while the Portuguese workers so desperately want an end to the colonial war abroad and fascist repression at home, Spinola's program is very different. He has already made it clear that he is not for granting independence to the African territories. Instead he hopes to set up a compliant leadership there that will accept some sort of federation status with Portugal—that is, he intends to continue the exploitation of the African people, but in the more subtle form used by modern imperialism

Leaders of Frelimo, the Mozambique liberation organization, have stated that if the objective of the coup was "to find new formulas to perpetrate the oppression of our people, then the Portuguese leaders are warned that they will face our firm determination."

SPINOLA'S FASCIST CAREER

Spinola and the elite military group he represents are no leftwingers, or even "democrats," for that matter. A volunteer with Franco in the Spanish Civil War, trained by the Wehrmacht in Nazi Germany, with the Germans at Leningrad, and an early volunteer in the war against the African liberation forces, Spinola couldn't have a more infamous background for a fascist officer.

Spinola is, if anything, to the right of the military junta which just last year brought fascism to Chile. He is no different than the officers around Colonel Franco in the 1930s. Only the times are different.

Commander in chief and military governor of Portuguese Guinea, recipient of Portugal's highest military honor for his role as exterminator of the African people, and finally deputy chairman of the joint chiefs of staff, Spinola has obviously acted to save Portuguese capital from disaster. If he is a bit more realistic about the interests of his class than some of his colleagues, that should make him no hero with the masses.

WHAT ROLE FOR WORKERS'

The junta has, for the present, opened the door for the return of the exiled leaders of the Socialist and Communist parties. Negotiations are now under way between them and the military.

But instead of seizing the time to mobilize the long-oppressed masses for a struggle aimed at the revolutionary seizure of power by the proletariat, all reports are that these leaders are offering their services to the junta to defuse the situation and to bring stability to the new regime.

Mario Soares, secretary general of the Socialist party, has said that independence must come to the African colonies "in an orderly way." Alvaro Cunhal, leader of the Communist party, told a tumultous crowd welcoming him back after 12 years of exile, "The Communist party is ready to assume its responsibilities in the present political juncture."

None of this has the ring, certainly, of irreconcilable opposition to the junta. Rather, it is reported that both parties are seeking a place in a popular front government—that is, a government with the Portuguese bourgeoisie.

REVOLUTION OR COLLABORATION?
Class collaboration instead of class struggle by the workers' parties is the road to disaster and defeat, as was demonstrated once again so tragically just last year in Chile. The task ahead of the Portuguese workers is not just to purge the fascists elements from power—what representative of the bourgeois order in Portugal is not steeped in fascism?—but to tear down the capitalist state apparatus itself

To project a peaceful development of "democratic" capitalism in Portugal now, when world capitalism is mired in crisis and the former empires are biting the dust, is to miserably deceive the masses.

The Portuguese socialists and communists must heed the words of their class brothers and sisters in Guinea-Bissau, who have felt the whip of fascism on their backs and whose struggle against it has opened up such great opportunities for the Portuguese workers. As Luis Cabral said just this week:

"Spinola talks a lot and he has been known to make a lot of promises. But we know that the only language he listens to comes from the guns of our forces hitting him and hitting him and hitting him again."

NORFOLK, Va., April 27—Several hundred Black and white demonstrators today, in the midst of an annual parade honoring the North Alantic Treaty Organization (NATO), demanded an end to the imperialist alliance.

Carrying signs and banners reading, "U.S., Portugal, NATO—out of Africa," "Down with NATO—tool for imperialist rule," and "U.S. troops out of Europe," 100 demonstrators walked on a loud and colorful picket line within sight of dignitaries and military brass assembled from all the NATO countries. About 300-400 more protesters massed farther up the parade

The demonstration was held during the yearly "Azalea Festival" parade, a tribute to NATO sponsored by Norfolk politicians and businessmen. Norfolk is the site of NATO's Supreme Allied Command Atlantic, as well as headquarters for the U.S. Sixth Fleet, stationed in the Mediterranean.

Two years ago, the same parade was attacked and disrupted by 1,000 anti-NATO demonstrators, mostly from the Black community of Norfolk. The festival's "queen" that year was a member of a prominent Portuguese ruling class family, and the festival was being held in honor of Portugal. The "queen" was driven from her float by a hail of rocks and bottles, as the people attacked the symbol of Portuguese colonialism and genocide in Africa.

FOR AFRICAN LIBERATION
This year, too, the focus of the predominantly Black demonstration was against the imperialist wars in Angola, Mozambique, and Guinea-Bissau, where U.S. companies have used Portugal and NATO as covers in a futile attempt to crush the liberation movements. Banners, signs, and chants expressed solidarity with the African liberation fighters and zeroed in on the United States and the other NATO countries for their role in financing and arming the Portuguese military.

The demonstrators also condemned the U.S. use of NATO bases to supply the Israeli military. As contingents of white men dressed in racist caricatures of Arab people marched by in the parade, the picketers chanted, "NATO out of the Middle East, Palestine will win."

Police security was heavy throughout the parade, as the militarists recalled being outmaneuvered and ambushed by the crowd 2 years ago. The "queen"—from Italy this year—was literally hidden from view by police guards. Nevertheless, both the Italian "queen" and the Portuguese "princess" were removed from the parade before they

reached the second anti-NATO contingent of several hundred people.

The demonstration was organized by three groups: the Tidewater Africans, a local organization composed mainly of Black sailors; the Black Student Union of Norfolk State College: and the Norfolk branch of Youth Against War & Fascism (YAWF). Also participating were the National Committee for the Defense of Political Prisoners; the African Liberation Support Committee; and the Defense Committee, an East Coast GI organization.

Among the demonstrators were workers from several of the area's largest plants, including such multinational giants as General Electric and the Newport News Shipbuilding & Drydock Co. (Tenneco). A number of U.S. Navy enlisted men, Black and white, also participated

### NATO IN CRISIS

This year's demonstration came at a time when the NATO alliance is going through the worst crisis of its 25-year history. Reeling from the losses of the Portuguese military in Africa, from the growing strength of the liberation struggles in the Arab world, and from the inability of the British to crush the Irish independence movement, the NATO countries are now beset by deepening economic crises and growing revolutionary sentiments within their own borders.

NATO's primary objective—the undermining, subversion, and destruction of the East European socialist countries and the Soviet Union—has proved a failure, and now the growing strength and prosperity of the socialist countries stand in sharp contrast to the inflation-ridden economy and crumbling social structure of the NATO countries.

So shaken is the alliance that Portugal was the only NATO country to back the U.S. Mideast policy during the October War, and a planned celebration of NATO's 25th anniversary on April 5 had to be cancelled because of internal divisions. In the Netherlands and other NATO countries there have been large demonstrations demanding an end to the Atlantic alliance, and Dutch students declared the week of April 20 a week of protest against NATO. In Norfolk the organizers of the anti-NATO action indicated that it is only the beginning of a continuing campaign to abolish NATO. The organizations will continue joint action to build a movement against NATO within the city that is its main base, and among the rank-and-file sailors and soldiers who fall under NATO com-

The recent overtures of Egyptian resident Anwar Sadat to the U.S. mark a narp turn towards imperialism and comes a severe blow to the Soviet Union, which s provided Egypt with massive d military aid for almost 2 economic

However, Sadat's move does represent the logical development of Egyptian policy since the Egyptian leader staged a political coup in May of 1971.

At that time, Sadat arrested Vice President Ali Sabry on the pretext that Sabry and Communist elements were plotting a coup. Soon after Sabry's ouster and arrest, all but one member of the cabinet, as well as many lower-ranking officials, were similarly purged.

The purges, carried out on the eve of then-Secretary of State Rogers' visit to Cairo, signaled a sharp turn to the right. This turn, as Sam Marcy pointed out in the Workers World issue of May 21, 1971, was the outcome of the suppression of the Palestinians in September 1970 in Jordan—a defeat which strengthened rightwing elements all over the Middle East.

The political and military gains won by Egypt in last October's war may have tended to obscure this shift to the right. But it has again become abundantly clear in the last few weeks.

a history of military interventions and proxy wars! On April 20 Sadat even went so far as to say that President Nixon and Secretary of State Kissinger had "made peace possible in this area for the first time in 26 years."

This is after the U.S. frantically rushed over \$2 billion worth of arms to Israel last October to try and revitalize its flagging puppet! And after Nixon declared a worldwide military alert as a warning to the Soviet Union not to intervene on behalf of the Sadat has now chosen to repeatedly praise the U.S. role in the "peace" negotiations going on in the Middle East—as if the U.S. were a disinterested peacemaker instead of the power with the greatest economic investment in the Middle East and

But even more than praising Nixon and Kissinger, Sadat announced on April 18 that Egypt would end its reliance on the Soviet Union for all its arms, after over 18 years. (To give a left cover to this turn to the right, he denounced the Soviet Union for not supplying Egypt with more arms since the October War.) This decision means, of

course, that Egypt will now turn to the Western capitalist countries for armaments, and in particular will welcome military aid from the U.S.

At the same time, Sadat promised to open up the door to foreign private capital in Egypt. The imperialist thieves are encouraged to invest by promises guaranteeing them against nationalization and expropriation. (On April 25, Sadat created the post of First Deputy Premier for Abdel-Aziz Hegazi, the former Finance Minister. Hegazi is a strong advocate of this new "open-door" policy.)

Washington has responded quickly to these overtures. President Nixon staged an unusually warm reception for the Egyptian ambassador; the U.S. carrier Iwo Jima was sent to Egypt to help clear the Suez Canal of mines (and to reestablish a U.S. naval presence in Egyptian waters after years of Soviet dominance in that area); and, on April 23, the administration asked Congress to appropriate \$250 million in economic aid to Egypt, the first such 6.14 since 1967. In addition, a three-man team from the Agency for International Development, infamous as a U.S. subversive CIA front, has already completed a 9-day tour of Egypt.

In the course of wooing U.S. imperialism's favors, President Sadat recently remarked that he had even been tempted to break Egypt's friendship treaty of 1971 with the Soviet Union. This 15-year treaty was signed by the two countries just after Sadat's coup in May of that year. It provides for continued economic and military aid from the Soviet Union, bars interference in the internal affairs of each country, and includes a pledge by Egypt to "continue along the path of socialist development."

Of course, Sadat's reconciliation with U.S. imperialism should have been recognized in the making by the Soviet leaders. It should have been clear to them that the Egyptian leader was not constructing socialism, but rather represented a bourgeois nationalist regime whose tendency to ally with imperialism would inevitably assert itself. If nothing else, the 1971 coup should have made that abundantly clear. 'FRIENDSHIP' TREATY

Exxon, Mobil, Texaco, Standard Oil of

California, Shell, and Atlantic Richfield had tried to resist the nationalization decree, not only for the sake of their Libyan booty but out of concern for their holdings throughout the Mideast.

In September, these six oil giants announced they would seek "international arbitration" against the "arbitrary and confiscatory" Libyan majority participation in oil production.

But Exxon and Mobil decided to abandon their campaign against the decree after watching Libya successfully take over the operations of the other companies, so far without compensation. Two smaller oil companies, Occidental Petroleum and a joint venture by Amerada Hess and Marathon, accepted the 51 percent nationalization from the start.

That the British Petroleum Co., whose Libyan branch was nationalized in 1971, has been unable to effect an embargo against Libya in time of oil shortage, was also important in convincing Exxon and Mobil to sanction the 51 percent nationalization.

Now Kuwait and Qatar have obtained agreement from the oil monopolies to immediately acquire 60 percent ownership, and Saudi Arabia is expected soon to announce majority control of the Arabian American Oil Co. Today, Saudi Arabia has 25 percent equity in Aramco, for which Exxon, Texaco, Standard of California, and Mobil were paid \$1 billion. Saudi Arabia is

guilty of the imperialist export of capital and the resulting superexploitation of foreign labor that process entails.

It should also be pointed out that where the Soviet Union and the other socialist-base countries carry on trade outside of the capitalist world market, the terms are much different. to pull itself up out of starvation and back-wardness while being almost totally cut off from the rest of the world. The prosperity that exists today is not stolen from the people of poorer lands, but is a proof of the tremendous superiority of the planned socialist mode of production—just as it is in

percent ownership

Nationalization is not the same as outright revolutionary expropriation. The former represents an agreement with the oppressive imperialist corporations to alter the terms of their exploitation—rather than an outright move to dispossess them. However, even this more limited form of struggle has met with the greatest resistance from the imperialists, and can throw their system into grave crisis.

In the oil nationalizations, the monopolies are involuntarily being forced to allow participation in ownership and profit sharing by the host countries, and the monopolies are not satisfied with the prices they are being paid for giving over a share in ownership.

in ownership.

But while oil production is passing more into the hands of the governments where the oil fields are, virtually all the marketing operation remains in the hand of the oil

monopolies.

The threat to their imperialist superprofits is the real crisis for the oil giants. In the past, they intervened militarily every time their iron grip on the oil seemed at all threatened. But today the military successes of the Arab states, with Soviet help, and the revolutionary threat of the masses stands in the way of their desire to forcibly occupy the lucrative oilfields. Under the circumstances, the oil companies have to accept the nationalization measures for fear that if they don't, they will accelerate a revolutionary process which will culminate in the Arab masses reaping the full benefit of the enormous wealth beneath their feet.

Most of all, the oil monopolies fear the day when outright expropriation by revolutionary socialists will completely stop

their exploitation.

Capitalist leaders—even reactionary ones—in the oppressed nations are at times capable of conducting a progressive struggle against imperialism. The recent oil embargo showed that. But the only forces capable of wrenching the national economies of poor countries out of the grip economies of poor countries out of the grip of imperialism are the oppressed classes led by a workers' party. Look at Ethiopia. In the 1930s, Haile Selassie led a progressive struggle against Capitalist leaders—even reactions

Mussolini for national sovereignty. Today, Selassie heads a crisis-ridden, im poverished land where the rulers have for years been completely subservient to im-

The history of recent coups in Bolivia, the Sudan, Uruguay, Chile, etc. gives a bitter, not-to-be-ignored lesson in the instability of the national bourgeoisie.

The speech of Mr. Teng—who was recently rehabilitated after being removed from party leadership during the Cultural

from party leadership during the Cultural Revolution—has nothing to offer the oppressed masses who must fight the class struggle in order to win national liberation. But the history of People's China itself—where the Communist movement liberated China only by defeating the national bourgeoisie and its leader, Chiang Kaishek—will outlast the present line of China's

Throughout the history of the South, in fact, throughout the history of this country as a whole, terror has been used as a weapon against the people, especially Black people. But another weapon, one that has historically accompanied the most brutal terror, has been the charge of rape. It has been used against the entire Black community, and has created myth, falsehood, and hysteria among white people. The rape charge against Black men has historically served as a cover for the perpetuation of the lynching of Black people, both legally and

period of Reconstruction after the Civil War, when wealthy whites, trying to regain control of the South, used violent night-rider tactics of intimidation against Black people. Members of the Ku Klux Klan, the Regulators, the White Camelias, and other racist, terrorist groups continued their campaigns of lynchings, murders, burnings, and rapes in spite of legislation passed to disband them.

Because the lynchers were directed by wealthy landowners and had judges and police in their midst, their savage acts were condoned, pardoned, and allowed to continue. By using the excuse of "rape," they covered these deeds and placed the Black man outside the pale of white sympathy. The lynch mobs, both "legal" and illegal, used the guise of the "protection" of women and the cry of white supremacy.

1899 Kissimmee Valley Florida Gazette, April 28

Alfred Cranford and of assailing Cranford's wife, was burned at the stake near Newman, Ga.... A few smoldering ashes, a blackened stake were all that was left. Not even the bones of the Black man were left in peace. Mrs. Cranford, the alleged rape victim, was not permitted to identify the Negro. The crowd was satisfied with the identification of Holt by Mrs. Cranford's mother, who did not actually see Holt commit the act. On the trunk of a tree nearby was pinned the following placard: "We Must Protect Our Southern Women."

Washington Times, February 18, 1900 COLUMBIA, S.C., Feb. 17—Will Buts, a Negro, 19 years old, was lynched in Aiken county. Three days ago he attempted to outrage Mrs. C.L. Weeks and failed. A crowd of 250 tracked the Negro fifty miles. He was caught by a farmer who received \$100 from the posse. . . . Buts was hoisted up and then shot to pieces.

Chicago Record, Jan. 4, 1901

ROME, Ga., Jan. 3—George Reed, a Negro charged with attempting to assault Mrs. J.M. Locklear. . . was hanged today to a tree. His body was then riddled with bullets by a mob of 150 men. Reed protested his innocence. . . After his arrest the Negro had been taken before Mrs. Locklear but she failed to identify him and he was returned to jail. . . . However, the mob, which had been seeking the prisoner's life, was not satisfied. The demonstrators were so pronounced that Judge Henry of the Superior Court, not seeing any reason for holding Reed, ordered the sheriff to release him. The mob, learning (Continued on page 14)

NEW YORK, April 20—Following a 312year struggle, the New York City gay-civilrights bill has finally been voted out of

Three times previously the bill had been sabotaged by the sexually bigoted majority of the City Council general welfare committee. Each slap in the face, however, only served to intensify the determination of this city's large homosexual community to force passage of the bill.

The struggle, led largely by the Gay Activists Alliance, has been very militant. At various times gay people have demonstrated in the City Council chambers, at the mayor's office, at the homes of antihomosexual politicians, at "high-society" gatherings, and in the streets.

### 300 IN MARCH

The latest action on behalf of the pending legislation was a march today of over 300 people organized by the Gay Rights Action Coalition. While speaker after speaker urged passage of the gay-rights legislation, a small group of disrupters, members of the rightwing National Caucus of Labor Committees, tried unsuccessfully

to break up the rally. This group shares with the police, the New York City firemen's organization, and various other rightwing groups, the view that homosexuals are degenerates and do not deserve civil rights. Even now, though most sources predict passage of the bill into law within a few weeks, powerful forces are working behind the scenes in an attempt at sabotage. And the bill itself, which is supposed to guarantee homosexuals equal access to housing, jobs, and public accommodations, was weakened by the addition of an amendment before it even left the general welfare committee.

The amendment, a statement to the effect that the bill shall not be construed as bearing upon standards of attire or dress, is specifically aimed, without openly saying so, at excluding transvestites from the bill's provisions. Transvestites, men who prefer to dress like women and women who prefer to dress like men, are certainly among the most oppressed of the sexual minorities. But what "terrible crime" these people are guilty of, it is hard to say. TRANSVESTITES NOT PROTECTED

The feelings and sexual acts which define the category of homosexuality are, for the most part, private, and thus many homosexuals can avoid discrimination simply by "passing" in their public lives as heterosexuals.

The appearance and mannerisms of those homosexuals who differ markedly from the sexual stereotypes of what constitutes a man or a woman, however, make them easy targets all their waking hours for the abuse and discrimination that this bill is supposed to outlaw.

But the withholding of basic rights to oppressed groups directly sanctions the continuing oppression of those groups.

The City Council members are criminal accomplices to the murder of William Battles. They also sanction, by their inaction, the whole spectrum of crimcs which continue to be perpetrated against New York's gay population. Equal rights now for all oppressed people!

NEW YORK, April 30—Measured by the \$10,000 they spent on ads, the free publicity generously provided by the bourgeois media, and the active collaboration of the Catholic Church, the anti-gay demonstration today at City Hall called by the Uniformed Fire Officers Association to oppose the pending gay rights bill was a distinct failure. Less than 100 hard-core bigots showed up. There were many gay people present to speak against the bigots, including an organized press conference of 50 representatives of the gay community. Until mid-April he taught a course in political freedom in the University's School of Continuing Education. Not only did NYU fire him, but they are refusing to pay his \$500 salary for services already rendered.

The firing of Ira Glasser is but one episode of blatant reaction coming down on the NYU community from its rich and rotten administration. On Tuesday, April 9, racist demagogue William Shockley was brought in to deliver his patented diatribe on "dysgenics," which winds up with a proposal for sterilizing Third World people (his inspiration is straight out of Nazi propaganda). Shockley was met by a determined coalition of Black and white students aimed at keeping him out.

To insure Shockley's presentation going over, NYU staged a full mobilization of its campus pigs and backed them up with a contingent of over 30 elite city Tactical Patrol Force porkers. In the face of all this, the demonstration managed to delay Shockley from speaking for almost 2 hours. As a reprisal, three students and one professor now face charges.

Shockley's appearance coincides with yet other developments. The administration now wants to reinstitute ROTC, which was driven off campus in 1970 shortly after the Kent State massacre. The university's

# UConn hits anthroporacism Storm of Black protest at

STORRS, Conn.—About 250 Black students took over the University of Connecticut (UConn) library Monday night, April 22. They held it throughout the night, making it unmistakably clear that they no longer would accept the university's thoroughgoing, blatant racism.

A week and a half earlier, Thursday, April 11, about 350 Black students had marched around the newly formed Biocultural Anthropology Department and demonstrated at the administration

the split in the Anthropology Department, elimination of Biocultural, and censoring of William S. Laughlin's and Benson Ginsburg's racist writings, research and teachings; an adequate Afro-American Cultural Center; funding and academic recognition for Black campus organizations; recruitment and admission of more Black and Third World students to all the state campuses, plus financial aid; a permanent "task force" composed of all minorities; a Black and Third World studies section for the library. One of their signs read: building. There they presented the demands of the Organization of Afro-American Students (OAAS), among them: an end to "Assortative mating means assortative

The Biocultural Anthropology Department received special attention because it is one of UConn's most obvious emblems of racism. The administration created this 'department' (by splitting the former Anthropology Department into two departments, biocultural and sociocultural) for the sole purpose of abetting one of the most insidiously racist and master-class theories espoused to date. This division made William S. Laughlin and Benson Ginsburg, authors of the theory (who had been denounced by other anthropologists), the most powerful anthropologists at

Laughlin and Ginsburg are trying to prove that racism and a master class are genetically inevitable. (Geneticists have also denounced them.) They claim that all races are "potentially equal," but that an "assortative mating" process has been going on long enough to cause marked

hereditary distinctions in abilities among groups of people.

these professors are promoted by many ruling class circles because they shift the blame for poverty, unemployment, poor education, bad housing, etc., from the oppressors to their victims—just as the master-race theories of the German Nazis did. In a period of growing economic crisis, this racist ideology becomes particularly dangerous. While the workers fight for full employment by shortening the workweek and opening up new jobs, the bosses are already saying there are too many people—especially poor people—and that sterilization and other forms of genocide must be used to avert disaster. Into this argument step the racist "theoreticians" who distort history and science in order to "prove" that the oppressed are inferior and should be eliminated. Like the pseudo-theories of William Shockley and Arthur Jensen, the ideas of

When the students seized the library, they demanded to speak to President Glenn W. Ferguson (former U.S. Ambassador to Kenya, also connected with the "Peace" Corps) by 6 a.m. He responded by sending the state police about 5:30 a.m. They brutally removed the students from the building, injuring at least 2 and arresting 219. All those arrested were charged with first-degree criminal trespass, which carries as much as 1 year in prison and a \$1,000 fine.

and The next night (Tuesday) about 80 white students occupied the library, demanding amnesty for the Black students and that the OAAS demands be met. They were removed arrested on the same charges.
Wednesday afternoon about 600 arto Rican, and white students

Puerto Rican, and white students held a large rally at the administration building to militantly reiterate their demands.

The OAAS has declared it will keep the issue alive this summer and renew the struggle in the fall. There is no way the "authorities," by trying to put out this one fire, can save themselves from the struggle of oppressed people, who have no intention of being dispensed with by an outmoded ruling class.

MILWAUKEE, April 9—After several weeks of distributing their racist, fascist literature, maintaining a "Dial-a-Nazi" number, and appearing at school-board meetings to oppose even the mildest integration efforts, the National Socialist White People's Party (Nazi Party) attempted yesterday to hold a public meeting in Milwaukee. They failed.

Members of Youth Against War & Fascism (YAWF) and other concerned people from the community have been consistently exposing and fighting the Nazis' efforts to surface here. The brownshirted fascists were shouted down at school-board meetings, a leaflet campaign against them was initiated, their own leafleters were often stopped by outraged speople, and an antifascist coalition is being

After being besieged by phone calls, the Black innkeeper of the Holiday Inn told the Nazis that the room had already been booked. The Nazis immediately screamed that they were being discriminated against and sought an injunction against the Holiday The Nazis had originally scheduled a public meeting at a motel in Milwaukee, which was immediately canceled. An attempt was then made to have it at a Holiday Inn in a racially mixed community, and they called in Matthias Koehl, the fuehrer from the Nazis' Atlanta headquarters.

At the injunction hearing the Nazis appeared, complete with brown shirts and swastikas. They weren't very pleased to find a delegation from YAWF observing the

the Nazis were not being discriminated against, the Nazis issued a statement saying, "There is no question that blacks are unequal to whites. Our biggest mistake was bringing them over here. ..." They then said they would hold a rally outside the Holiday Inn that night anyway.

Youth Against War & Fascism was there to give them the greeting such scum deserve. As 20 YAWF members and supthe Nazi party were spotted in their uniforms outside the building. Like the dogs they are, they beat a hasty retreat at the approach of the militant demonstrators.

A picket line was set up with banners reading "Stop the Nazis—racism is the enemy of all working people" and "Power to porters approached the motel, 4 members of the Nazi party were spotted in their proceeding. When the Black judge ruled that the Nazis were not being discriminated

### Dennis Anderson

MILWAUKEE. April 28—DENNIS ANDERSON's trial was scheduled to begin here, after months of delay, on Tuesday, April 23. Over 20 members and supporters of the Prisoners Solidarity Committee (PSC) demonstrated outside the courthouse for a half hour before the trial was to start. A week before the trial was to start. A week before the trial was to start. Dennis Anderson be dropped and that there be an investigation into the death of Howard Pierce. Pierce died in the Milwaukee House of Correction as a result of gross neglect on the part of the prison's medical and administrative staff. He had been incarcerated for failure to pay a \$25 fine and died of convulsions that lasted over a day. Instead of getting medical attention, he was thrown into isolation and died there.

McCann refused to drop the charges against Dennis or to indict those responsible for Pierce's death.

During the demonstration on the 23rd the demand was again raised to drop the charges against Anderson, who is on trial precisely because he is an ex-immate who has continuously fought against the brutality and neglect which inmates are subjected to daily.

It was clear in the courtroom that the government was again unprepared for trial. One of its witnesses had failed to appear, and when he was found after several hours he had apparently forgotten his story, because the prosecutor requested time to "interview" him before the trial. After still more delay the jury panel was still not interview him before the trial.

### Karl Armstrong

Waupun State Prison in Wisconsin. He was convicted on state and federal charges of setting off a bomb in the Army Math Research Center in Madison on August 24, 1970, which accidentally killed a graduate student. The state trial resulted in a sentence of 25 years.

On March 29, 1974, during a visit by a friend, Karl was subjected to arbitrary harassment by the Assistant Warden, Harvey Winans. When Karl and his visitor protested, she was removed and he was dragged, face down, to the segregation building.

Not until a week later did news of the incident appear in the local press, and then it was the prison administration's falsified version. In an effort to influence the April 18 sentencing on federal charges, the prison officials had provoked Karl, locked him away in solitary, and fed lies to the press. But other prisoners and visitors who witnessed the incident came to Armstrong's support, writing letters to the federal judge, Governor Lucey, prison officials, and the movement media. They called for Karl's release from segregation and for an investigation to be conducted by prisoners and the public, which would lead to the dismissal of prison officials.

Doyle sentenced Karl to 10 years to run concurrently with the 25-year state sentence. He placed parole authority entirely in the hands of the federal government. In the statement issued by Doyle, he admitted that the Vietnam war was criminal and tried to justify Armstrong's incarceration with the argument that two wrongs don't make a

But it was precisely the militancy of the antiwar movement that hastened the U.S. retreat from Vietnam. And the judge who preaches about those who "attempt to impose their will on others by physical force rather than by persuasion" sees nothing of the sort in his own imprisoning of Karl.

What charges have been brought against the war criminals in the Pentagon? The prison administration has sentenced Karl to 120 days in segregation and 3 days in solitary, so that he cannot have any visitors except his parents until August.

HOUSTON, Texas, April 27-A recent conversation with members of the Houston in 2 Defense Committee shows that the struggle to defeat the police frameup of these young activists is gaining ground.

The trial of those five of the Brothers who face life imprisonment will begin on May 20. The political issues behind their carrest—police brutality and the Mideast War—are arousing the sympathy of many Houston residents, particularly in the oppressed Chicano community.

"One of the biggest challenges faced by the Houston 12 Defense Committee since the police attack on us last October has been reaching the people on the street. There has been a news blackout about our case. With local newspapers announcing record profits by the oil companies for the first quarter of the year, the Oil Establishment doesn't want one wave to rock its boat.

"The only way the defense committee scould deal with this was to conduct a massive leafleting campaign on the streets." Boswell, a native of Tennessee, has received such treatment prior to any conviction, because he is openly gay, in the face of organized terror used against him by the courts, police, and prison officials. It was clear from the argument of the prosecutor, from the attitude of sentencing Judge Kellam (a member of one of Norfolk's richest old-Southern-Democrat, ruling class families, and a notorious racist), and from the "defense" of Boswell's public defender ("We have here, Your Honor, a very sick young man") that Boswell's real offense was his sexuality.

A parade of smirking witnesses for the prosecution, including three FBI agents and three Norfolk cops, each described in detail the contents of Boswell's car at the time of his arrest last October: "makeup, a "woman's' wig, purse," etc. A copy of his fingerprints was introduced as evidence and it bore, under his name, an "alias Lana Turner." The Norfolk cop on the stand was asked about this by the prosecutor and answered, "Well, I guess some of the guys down in the lockup did that."

Before the sentencing, Boswell was allowed to make a statement to the court, in which he defended his right to live and love as he chooses, and in which he attacked the courts and prison system as vehicles of oppression. Judge Kellam repeatedly interrupted him, at one point saying, "You mean that you don't want to change?"
