Lagos, Nigeria — Many Nigerian youths were clubbed by the police in Lagos recently, during demonstrations at the American and Belgian embassies protesting the brutal murder of Prime Minister Patrice Lumumba, by NATO.

The demonstrations had been peaceful until the demonstrators nearly reached the American embassy, when a British police officer, Mr. Wilson, ordered tear gas to disperse the demonstrators. The police then started to club them. Several of the youths were arrested and many of those injured were hospitalized.

Meanwhile, one of the three main political parties in Nigeria, the National Council of Nigeria and the Cameroons (NCNC), has taken up the matter of this police brutality-lead by the British officer Wilson.

They are asking the Federal Government to investigate why these youths were beaten and are demanding the punishment of Wilson. The NCNC also recalled that it was this same Mr. Wilson who ordered tear gas to be used against students sometime ago during the demonstration against that obnoxious Anglo-Nigerian Defense Pact in Lagos, which led to the arrest and trial of six of the students. #### Afro-American Workers Hit Hardest by Layoffs As Capitalist Crisis Deepens

The U.S. government officially admits there are 5.7 million workers unemployed in this land of so-called "opportunity," "free enterprise" and "democracy." This is the highest amount for any time in 20 years.

Of this number, 250,000 have been added since John F. Kennedy assumed office as President of the United States.

Kennedy campaigned on a promise to "do something" about unemployment. About all he has done so far is to argue with the Republicans about whether there is a depression or not. Fat-headed liberals may compliment Kennedy for recognizing the existence of unemployment, but the unemployed themselves are still waiting to go to work.

When Kennedy sent his "bold" program for the unemployed to Congress last month, the conservative, Republican New York Herald Tribune breathed a sigh of relief at the "moderation" of the program and said:

"It is clear that Kennedy will not rush in where bankers fear to tread.'

Two weeks ago, the cautious, rightwing National Urban League made a survey which revealed that unemployment among Afro-American workers in 12 of the country's largest cities is three times the general rate..

The New York Times noted last week that even if "prosperity" returns later this year, unemployment may continue for a time on the same level! The AFL-CIO warned that unemployment may climb to an official 8 million if no serious action is taken.

The millionaire President, after all his talk about the growth gap, the economic lag, etc., etc., has not taken-nor even proposed—one single step for alleviating the chronic unemployment that is growing more apparent every year. The billionaires' Congress is buzzing

and droning on about giving a few cents here and a few cents there. It will talk, talk, talk. But it will never really DO anything without the action of the aroused millions, and the threat of their taking things into their own hands.

#### Prominent Newspaperwoman Says—

### **Build Defense Guards and Fight Back!**

(On February 27, a brave woman made a stirring call to action in behalf of the oppressed. She is Pat Alexander, Editor of the Los Angeles Herald-Dis-

The question of self-defense for Afro-Americans who have been victimized both by racial violence in the South and Police Brutalthroughout northern cities have been uppermost in my mind for several vears . . .

However.,,, concrete evidence that others were thinking along the same line came to my attention, on December 1, 1960, when Dr. Lonnie Cross, speaking at Atlanta University, Atlanta; Georgia, raised the question forcibly and intelligently.

Dr. Cross, a professor of Mathematics, and the Dean of that department of Atlanta University, had this to say in part:

"The recent events in our southland indicate that the Afro-American movement for liberation from economic, political, social, cultural humiliation and degradation is on the verge of a tremendous leap forward." "The events," he said, "of Jacksonville and New

Orleans underscore this in particular, for they clearly show that the rank and file of our people are not yet victims of the 'Non-violence and love' narcotic." Here, he was referring to the "turn the other cheek" and-love-the-man-who-is-lynchingyour-brothers psychology, preached and spread by Dr. Martin Luther King.

Dr. Cross continues by saying, "These same events have also raised in sharper form the crucial questions of tactics and strategy, and of course the proper leadership for Afro-Americans." . . .

Dr. Cross, of course, was dealing with the problem of violent attacks directed against our people in the South-via Mob Violence. While I support Dr. Cross' concern for our people in the South, as the editor of a national Afro-American newspaper, I must concern myself with the problem as a whole wherever it shows its ugly head.

In this respect then, let us concentrate on historic development of the whole idea of Self-Defense, why the need for Self Defense in northern communities, and how and when should they be organized . . .

The right of self defense is universally recog-

nized. It is generally conceded that a nation or an individual has the right, and indeed the duty to act in self-defense against murderous attack. In jurisprudence, for example, the act of killing in selfdefense is called justifiable homicide, and is not considered a criminal offense.

History is replete with examples of individuals, groups and nations exercising that right, and being applauded and eulogized for it. The American, Revolution is one such an example. . . .

Many examples could be cited from both American and world history of people organizing selfdefense groups to defend their lives, rights, property and human dignity from violence.

For an example, in Tzarist Russia. Jewish communities organized defense, united to protect themselves against government-instigated pogroms carried out by hoodlums and anti-Semites. And, in the last World War, the Jewish ghetto in Warsaw, Poland, put up a heroic resistance against the Nazi "Master Race," and received world applause for it.

### Cokes Instead of Bibles

As March was coming in like a lion in some parts of the country, John F. Kennedy came out like a lamb in Washington, D.C. with the announcement of a "Peace Corps."

And all the newspapers, from the reactionary Hearst and Scripps-Howard chains to the bleeding-heart liberal New York Post, greeted Kennedy's bleating "Peace" plan with hosannas and hallelujahs.

The reason is not hard to find.

The "Peace Corps" idea is another gimmick to sell U.S. imperialism to the people of underdeveloped lands-that is super-oppressed colonial countries. It is a device to soften them up, lower their resistance and ensnare them in the toils of imperialist trade and culture for the benefit of imperialist exploitation.

The idea is for "dedicated" boys and girls just out of college to go to Africa, Latin America, Asia, etc. and teach U.S. techniques to the people and conquer the people's aversion to U.S. imperialism.

In the old days, missionaries did this with bibles. But the slaves of imperialism are now adopting the religion of rebellion and have little respect for the religious representatives of imperialism. So a new type of representative is necessary - missionaries in Bermuda shorts - nice girls in pigtails, young fellows in crew cuts - all "befriending the natives" - instead of converting them to the bible, winning them over to Coca Cola and long-playing victrola

It is interesting that the reactionary right wing has not attacked this as another "egg-head plan" or "fuzzyminded globaloney."

There used to be a big argument in this country between the "liberal" capitalists and the more reactionary capitalists on just how to handle the revolutionary masses. Now, with the world in flames, and more doubt than ever about the power of atom bombs to put out the fire, there is a touching display of unity on this all-important question.

The "liberal" Post voiced the hope of the whole capitalist class when it said: "The Peace Corps could be our mightiest battalion."

But it is safe to predict that the colonial masses, after several centuries of experience with the Bible Battalion, will not long be deceived by the Peace

### Klan's Friend - and Kennedy's

### Stevenson Oils Up for War

Adlai Stevenson is one of those "liberal" servants of a decadent ruling class who is most valuable in time of a severe crisis. This is because he has so long duped the middle class liberals as a "moderate" and a "friend of progress" that he can more effectively lead them into imperialist war.

When he took up his duties in the UN a couple months ago, we said he was "imperialism's ideal choice for U.S. Ambassador to the United Nations."-Workers World, December 23, 1960.

He has been proving the correctness of our estimate ever since that time. But on March 2 of this year, he outdid himself with an unctuous luncheon talk about "freedom" for Africa that combined suave appeals to African nationalism with ringing denunciations of imperialism (!), veiled threats of war against the Soviet Union, and ready references to the revolutionary past of the United States.

After warning that Africa was becoming "Balkanized," Stevenson threatened—between his faked and stagey

"Then in 1914, a bullet killed an archduke—as a bullet, this unhappy winter, killed Lumumba. And men stood helplessly by and watched until all the world was engulfed in the horrors of war.

"Africa is the Balkans of today. Any outside power seeking to manipulate its griefs and searchings and first fumbling efforts to stand alone risks bringing down on Africa and on the world the dread possibility of nuclear destruction."

This was a polite, poetic and slaughterous warning to the Soviet Union to refrain from supplying any more arms to the freedom forces in the Congo. The same slippery Adlai Stevenson who hypocritically advocated stopping nuclear bomb tests in 1956 now openly threatens nuclear war!

But that is not all. This slick schoolmaster of imperialism continued to lecture the Soviet Union as follows:

"And to the Soviet Union I would say . . Stay your ambitions. Think twice about your intervention. . . . Do not sabotage the only institution (i.e., the UN!-ed.) which offers an alternative to imperialism."

Stevenson, of course, did not mention that it is Belgium, not the Soviet Union, which owns 3.5 billion dollars worth of the Congolese people's gold, diamonds, uranium, ivory, etc. And he did not refer to the 500 million dollars worth of the same owned by the United States capitalists, who pay the same starvation wages as the Belgians do to Congo

To top his tall story of the 'goodness' of the U.S. rulers as against the 'badness' of the Soviet Union, he took a go at American history:

"Indeed, it was in these United States that the first practical steps were taken to raise the principle of anti-colonialism from a hope to a fact. The 'shot that echoed around the world' at Lexington echoes on to this very day."

(These "echoes" were pretty weak at the UN on last December 14 when the U.S. Delegate failed to vote for a motion to end colonialism!)

What a true and faithful servant of imperialism and what a persuasive advocate of imperialist war is the "peaceful" Adlai Stevenson! How much harder it would be for Wall Street's battleships to visit the Congo (they started to Mar. 6) without the smokescreen of his "antiimperialism" and the oil of his "moderation"!

### "Civilized" Barbarism Tortures 'Backward' Algeria

The GANGRENE is an enlightening and true account of the vicious torture inflicted by the French government on supporters of the Algerian revolution.

It is a narrative of some of the most damnable torture endured by man. This inhuman treatment was inflicted on seven Algerian intellectuals by a special French police squad which is similar to the Gestapo in Germany and the F.B.I. in the United States.

These young men were abducted by the police and taken to an out-of-theway spot, where they were tortured.

One of the men involved was a dental student whose brother was active in the Algerian revolutionary government. Another was a political science student.

A student in the School of Public Works was so badly mutilated and beaten that he appeared more dead than alive after the ordeal. The other four men were a pharmaceutical assistant, a journalist, a commercial traveler, and a student of science.

The special police squad was able to inflict the maximum of pain and torture and yet keep these men barely alive.

Electrodes were applied to various parts of the body. Water was applied before the electrodes were placed on the skin. This was to increase the pain and yet leave no traces on the body.

After the police squad finished its work these men were so close to death that they were quickly transported to the hospital to keep them from dying in

The GANGRENE was confiscated by the de Gaulle government on June 20, 1959, just four days after it was published. A new set of plates was made for a second edition, but these were quickly smashed by the French police.

The seven Algerians have suffered sadistic indignities and merciless hate. To date, they have been refused a trial and a chance to tell the facts to the

Of course, the French government refuses to admit that such practices exist and therefore has done nothing to abolish them.

Accra, Ghana, March 1-In Ghana today, with everybody from scavengers to Cabinet ministers, the topic of discussion is Lumumba's death and the Congo crisis.

It was one o'clock on a Monday, when the radio announcer broke the news of Lumumba's dath. Consternation and indignation followed, and Ghanaians described the murder as "premeditated."

The President of Ghana, Osagyefo


Dr. Kwame Nkrumah, solemnly drove to the Radio Station in Accra and condemned the architects of the murder of Lumumba and his colleagues.

He said, "The three men had been killed because the United Nations, whom Mr. Lumumba himself, as Prime Minister, had invited to the Congo to preserve law and order, not only failed to maintain that law and order, but also denied to the lawful government of the Congo all other means of self-protection.

"The murder of Mr. Lumumba and his colleagues was unique in that this is the first time in history that the legal ruler of a country has been done to death with the open connivance of a world organization in whom that ruler put his

President Nkrumah added that Africans should not ignore the fact that the murders were most carefully prepared

Demonstrators carried placards. "Lumumba Imperishable," "Belgium and America have killed Lumumba," "Kasavubu—Mobutu—Tshombe must pay for the price of treachery," "Shame Unto Dag Hammarskjold." African drums throbbed while demonstrators, all clad in mourning cloths, sang songs in honor of Lumumba. The crowd, on reaching

the Local United Nations Information Centre, tore into pieces the United Nations flag.

For eight days the President of Ghana directed that all Ghana flags should fly at half-mast. Ghanaians mourned Lumumba's death as though he was a leading statesman of Ghana.

A Chief's House of Representatives in Brong Ahafo, northwest of Ghana, has congratulated Dr. Kwame Nkrumah on recognizing Antoine Gizenga's Government. They have pressed for the arrest of Congolese thugs, including Joseph Kasavubu, Mobutu and Moise Tshombe.

> Upon their arrival, they proceeded to the Lincoln Memorial to place a wreath there. Then going to the White House, they set up a picket line. Marching four abreast, they formed an oblong stretching the entire length of the grounds fronting the White House.

> The marchers carried signs showing their non-support of U.S. policies toward Cuba. Some of the signs read: "Let Americans see the truth about Cuba-End the travel ban," and "We want to go back to Cuba!"

> The latter expressed the plight of the Cubans in this country who support the revolutionary government of Cuba and are prevented by the U.S. capitalist government from returning to their

> During the march one of the heaviest downpours of the season began and continued for hours. The rain soaked the demonstrators but did not dampen their spirits. At the height of the deluge they began shouting "Viva Castro . . . Viva

> The immediate area of the White House being districted as a "Quiet Zone," the Washington policemen ran about in a frenzy while the demonstrators shouted "Viva Castro" . . . . within earshot of Jacqueline's bedroom.

> After picketing, the group boarded their buses. The caravan moved through the residential area when leaving the city. The demonstrators, with bus windows open wide, waved and shouted to pedestrians, "Viva Castro." Many waved back enthusiastically.

It was a great day.

### Where Would Cuba's Enemies Have Stood in 1776?

The Cuban Revolution is different from the Revolution of 1776. But the difference does not lie in any lack of "democracy" or "free elections" or the number of traitors or the amount of bloodshed.

In 1776, one-third of the U.S. population was loyal to King George III and literally up in arms against the "subversive, radical fanatics" like George Washington, Paine and Jefferson.

No general election was held until 1789-13 years after the revolutionary leaders had said that "all men are created equal." And then neither white women nor Afro-American men or women were allowed to vote. With the great majority of the population disfranchised, Washington was elected President. And he was the only candidate!

During and after the Revolution, there were a large number of traitors who defected to the British. Like the Cuban defectors of today, they were most numerous in the following categories:

- 1. The officials—Men holding positions in the civil, military and naval services.
- 2. The professionals-Lawyers, doctors, teachers and preachers.
  - 3. Large landed proprietors.
- 4. Wealthy merchants whose businesswere nurt by the disruption of trade with Britain.
- 5. Miscellaneous personal servants and retainers of the upper class-also criminals and dregs of society.

Benedict Arnold was not the only defector of high military rank. There were a number of officers of lesser rank, who also turned traitor when the going got

As the Revolution proceeded, the revolutionists expropriated practically all properties of defectors as well as British firms and interests. Few indemnities were paid.

Defectors were imprisoned or hung. Laws against them were not repealed until 1812.

Today, revolutionary Cuba is com-

pelled to take some of the same kind of drastic measures in the interest of progress that revolutionary America once did. (But of course Cuba has infinitely more equality than the U.S. had in 1776 or any other time.)

Today, the capitalist rulers of the United States have buried the Revolution of 1776 under a mountain of platitudes. And they are trying to bury the Cuban Revolution of 1959-61 under a mountain of lies.

They slander the Cuban Revolution as George III slandered the American Revolution.

The difference between them and George III is only that they are so much more powerful, more dangerous and more murderous against their colonial slaves and ex-slaves.

### 8,000 Workers

Kennedy doesn't want to put the unemployed back to work one-tenth as much as he wants to make the capitalist system work.

For example, if Kennedy makes good on his threat to ban the importation of Cuban tobacco, some U.S. workers will be hurt more

There are 6,000 to 8,000 cigarmakers in Tampa, Florida, who roll fine Cuban tobacco into expensive "Havana" cigars.

Nearly all of these will lose their jobs if the import ban goes through.

But of course, that's all right with Kennedy. He figures what hurts revolutionary Cuba is bound to help U.S. capitalism-and to hell with a few thousand U.S. workers!

### This Billionaire Is Asking YOU To Build Him a New Home!

A great deal of publicity has been given to the fire which damaged New York State Governor Rockefeller's executive mansion and destroyed some of his paintings.

The biggest play in the newspapers and on the radio and T.V., shortly after the fire occurred, was towards the Governor's "heroism" and the unfortunate loss of \$350,000 in "art treasures."

But after the drama wore off, a more sober thought was thrust before the public: the state was thinking of building or buying a new residence for the Governor. Or, to put it another way, Rockefeller was thinking of building or buying a new residence for himself.

The reasons given were that the architectural style of the mansion is no longer "fashionable" and the section of Albany surrounding it has "deteriorated" since the mansion was built.

And why shouldn't the state give Rockefeller a new home? After all, he

#### Unemployment To Rise Still Higher

The AFL-CIO Executive Board has just warned that unemployment would rise to 8 million by next year if national productive output~stayed at present levels. This would be an increase of 2.6 million unemployed with the same goods

In Enugu, capital of Eastern Nigeria, armed policemen guarded the office of the United States Information Services while demonstrators protesting Lumumba's murder were in action. Speakers at a rally which later followed blamed the NATO powers, headed by the United States, for the murder of Patrice Lumumba.

One of these speakers, Mr. C. A. Abangwu, Deputy Speaker of the Eastern House of Assembly, said that the Western Powers were committing murders in the Congo because of their interests there. He said seventy per cent of the mineral wealth of the Congo belonged to the United States, Britain, France, and Belgium.

Another speaker, Mr. Mbazulike Amechi, Parliamentary Secretary to the Nigerian Federal Minister of Information, revealed that the American Government had issued the order for the murder of the legal Congolese Prime Minister, Patrice Lumumba, in Septem-

ber of last year. Mr. Amechi declared: "It will be foolish for anybody to think that by achieving independence the tasks of the Nationalists of Nigeria are over. We have achieved independence to be able to gov-

ern ourselves, but I am not yet con-

vinced that we are governing ourselves

Also, the Parliamentary Secretary to the Premier of Eastern Nigeria, Mr. John Imolu, told the large audience at the rally: "I do not know what they call Communism, but if Communists love us and support us, we should also support them."
