Afro-Americans **FLOGGED**

In Dover, Delaware last week, a Superior Court Judge sentenced Franklin W. Cannon Jr., a 20-year-old youth, to be publicly flogged. The punishment is to be 20 lashes!

Delaware's infamous "lash law," passed in 1717, was at that time a commonplace in the southern states. Every other state has since rescinded such laws, but Delaware's excuse for keeping it is that "it is a deterrent to petty crime."

But it is an open secret that this vicious punishment is not for white men, though white men frequently commit petty crimes in the state of Delaware. So far as is known, every public flogging in Delaware since 1717 has been perpetrated against an Afro-Amer-

Appropriately, the name of the judge who ordered this inhuman punishment is—Judge Lynch!

United States Votes To Defend South Africa's Jimcrow System

If the UN ever passed a resolution that was more than a pious wish or a deploring of evil, it was on Tuesday, November 6, when 67 nations resoundingly defeated 16 imperialist governments and their stooges with a ringing condemnation of racist-ruled South

The resolution went a great deal further than just condemning South Africa, however; it called for sanctions. That is, it called upon United Nations members to close their ports to South African ships, prevent their ships from entering South African ports, boycott all South African goods and refrain from exporting goods, including arms and ammunition to the South African government. It also recommended the expulsion of South Africa from the UN.

The Asian, African and socialist bloc of nations voted solidly against the United States and the NATO alliance and Japan.

Delegate Francis T. Plimpton, speaking for the U.S. government, said:

"We think that the expulsion of South Africa from the United Nations would not advance our common objective of ending apartheid (jimcrow on a super-scale), but would make the achievement of that objective more difficult."

J.E. Jantuah, Delegate from Ghana, answered him by asking:

"Whether it was not true that the United States is applying sanctions to Cuba, which unlike South Africa, has not been condemned by the United Nations?"

Mr. Jantuah added that Peoples China, which "is alleged to be not peace-loving" was banned from the United Nations by the same members who opposed getting rid of South Africa, when South Africa was "clearly and constantly violating its charter obligations."

Mr. Jantuah's eloquence—and logic fell on deaf ears in the U.S. delegation, however. For it is well understood among U.S. diplomats that the big business interests they serve are allied with the white capitalists of South Africa. These diplomats reserve their condemnations, their votes of sanction and their most theatrical speeches for the Cubans who are fighting white supremacy, not for the South Africans, who like Mississippi, are enforcing it.

Old Gestapo Technique Put to New Use

The U.S. has dusted off an old weapon borrowed from the Nazis in its continuing war of aggression against Cuba. Just as the Nazis framed the labor and progressive leaders in Hitlerite Germany, so the CIA, in collaboration with State Department and FBI Agents, pulled one of the rawest and most outrageous tricks in the book.

The FBI arrested three Cubans in New York on November 17 on charges of "sabotage and conspiracy for the purpose of injuring and destroying national defense materials in the New York area."

They are Roberto Santiesteban Casa-

nova of the Cuban Mission to the UN, Marino Antonio Esteban Sueiro y Cabrera and Jose Garcia Oreliana. Also arrested with them was a North American woman, well-known for her support of progressive and civil liberties causes. She is Ada Marie Dritsas.

Hours after the arrests, the Havana radio exposed the frame-up as a mere retaliatory maneuver to offset the arrest of the CIA intelligence agent in Cuba who tried to blow up a mining installation, but was caught red-handed.

Naturally, this received very little publicity in the U.S. press and none at all in most of the big New York dailies, which carried screaming headlines about alleged "sabotage plots" in New York, when the real saboteur was the one the U.S. had planted in Havana.

The male defendants in New York were badly beaten up before being taken into custody and their bail was set at so excessive an amount (\$250,000) that their release on bail was practically impossible.

These Bombs are for Real!

Havana, Nov. 20-A U.S. plane is reported to have flown over the Cuban merchant ship, Rio Damuji, today and dropped 11 bombs, some of which exploded just 50 feet above the vessel.

In Washington, the Pentagon denied any responsibility by the U.S. You can be sure, however, that the bombs were not manufactured in the Soviet Union!

What's All the Shouting For, About the IL 28 "Offensive" Bombers?

Having taken the United States and the rest of the world to the brink over the Cuban missile bases, Kennedy is now apparently getting up steam to do the same thing over Cuba's possession of 30 Ilyushin 28 bombers which are "offensive" to him and to the U.S. banker-general cabal.

Quite aside from the question-where does Kennedy get off telling another nation what kind of weapons are offensive? there is also the question-just what kind of super-weapons are these Il 28's anyway? And just how do these 30 planes militarily threaten the United States?

Drew Pearson said in his syndicated column on November 13:

"They are old, and sitting ducks for any bomber attack from the United States."

The London Times said on October

"The Il 28 tactical bomber is a type normally supplied by the Soviet Union to its allies. . . . It is an old aircraft, virtually superseded in the Soviet Air Force and it is the view of aviation experts in London that although it may be physically capable of carrying a nuclear weapon, its presence in Cuba is not enough on its own to constitute a serious threat."

The Baltimore Sun admitted on November 3:

"Perhaps the principal value of the Ilyushin bombers to both the Soviet Union and Cuba is their possible use as training planes."(!)

The IL 28's maximum speed is about 550 miles an hour, somewhat slower than the cruising speed of the U.S. civilian jet planes regularly hopping York to Chicago and Los from New Angeles. U.S. Air Force fighter-interceptors are about twice as fast as the



Will New Ohio Governor Send Her to Dixie?

Mae Mallory's Fight for Freedom

The importance of Mae Mallory's fight against extradition has been encouragingly emphasized and the case made a significant impact on the recent political arena in the State of Ohio. The question now is: Will the new Governor, along with his aides—those who got a political ride on the back of the Mae Mallory extradition issue—effect the release of Mae Mallory?

Mae Mallory has been waiting nine months in a drafty and barren county prison with none of the meager benefits that state and federal prisons have. Prisoners come and go in Cuyahoga County Jail. They are only there a few days to a month or so, awaiting trial, awaiting sentence, or serving short sentences for petty crimes or misdemeanors.

Mae Mallory has been waiting there so long because she is fighting ex-Governor DiSalle's order extraditing her to face trial on a phony kidnapping charge in Monroe, North Carolina.

The Ohio courts have refused to grant her bail while she is challenging the extradition in the U.S. Supreme Courtalthough she had been granted bail for a period of five months previous to her present imprisonment and never violated the conditions of her bail.

The new governor, James Rhodes, has the power to cancel DiSalle's ex-

tradition order. Many Afro-Americans must have voted for him in the hope that he would do just that, because the Black communities in Ohio changed their voting patterns for the first time in decades. But Rhodes has not yet said what he would do for Mae, and he has not yet assumed his office.

Mae's tireless supporters in the Monroe Defense Committee also point out

"Judge Kingsley Taft, State Supreme Court Judge, who ruled in favor of Mrs. Mallory's case in the Ohio Supreme Court—defeated Justice Weygandt in the race for Chief Justice of Ohio's High Court. Taft and another Justice, it was reported, ruled in favor of hearing Mrs. Mallory's case, while five others, including Chief Justice Weygandt, ruled against." (But the extradition was blocked by other means.)

Nevertheless, the Committee is not banking primarily on the gratitude of politicians; it is still making its primary appeal to the masses, and particularly to the Black masses of Ohio, who have taken Mae Mallory to their hearts.

The Myth of India's "Independence"

Current political mythology presents modern India as a country that is both "free" and "independent."

India has also been described more than once in the last decade as "socialist." But nothing could be further from the truth. And its social system, unlike that of the socialist countries, is sometimes referred to as a "revolution by consent."

Let's look at the facts.

First, how independent is this former British colony since the day in 1947 when it won formal independence from the British Empire? Did the new era usher in a spirit of Indian "free enterprise" and "rugged individualism"? Has India been able, these 15 years, to develop its own industries, amass its own capital, exploit its own mines and natural resources?

Four years after the British supposedly left India, 838 of the 1135 joint stock companies existing there were foreign owned. These 838 companies burrowed into the fields of banking, insurance, manufacture, mining, transport, agriculture and utilities—in fact into every aspect of Indian economic life. But were they perhaps only filling the gap until native entrepreneurs learned to fend for themselves?

Hardly! The next decade proved to be a bonanza for the capitalists of every western nation. A golden stream of capital poured into India with ever-increasing momentum, while the Indian masses continued to starve or at best eke out a wretched existence in the growing number of foreign-owned factories.

The \$512 million of foreign investment in 1948 grew to \$1 billion, 220 million by 1959! In the first years after "independence" Britain owned most of India's corporate wealth, but ten years later U.S. capital had the lion's share.

India's dependence on foreign capitalists is matched by her dependence on foreign governments. Her debt to the British government grew from \$67 million in 1955 to \$273 million in 1960—while her debt to the U.S. government increased in the same period from \$184 million to more than \$1 billion. (These figures are exclusive of the tremendous debt to individuals and corporations in the U.S. and Britain.)

But aside from her relations with the rest of the world, what about social relations within India itself? What kind of "socialism" has this "revolution by consent" produced?

There were 538 Princes in India at the time the British got out. Most of

them were petty princelings who owned tracts of land varying in size from a few square miles to an area as small as a city block. Nehru's "socialist" regime persuaded many of these little princes to accept life-time, tax-free pensions in exchange for their lands (while the teeming millions of poor peasants groan under a heavy burden of taxation, and half of them have never—nor do not now—own any land.)

On the other hand, the dozen or so

big princes owned vast territories—and still do. Several of these are greater in area than England and Scotland together. These princes have not accepted pensions in exchange for their lands. After all, they argue, India's was a "revolution by consent"—and "we simply have not consented"!

Nor has the landlord class consented to the Congress Party's faint-hearted reforms. It has learned to circumvent them. The many thousands of villages, holding the great majority of India's population, continue to be ruled by their landlords, who continue to enjoy the privilege of being bankers and political bosses as well. The proof of their continuing power can be seen in the number of evictions of tenant-farmers since 'independence." In the province of Hyderabad alone, one half the tenants have been evicted to make room for landlords' relatives in the last ten years.

India is still, despite her parliament and Congress Party, a colony of imperialism, where a few hold vast wealth and power, and the millions upon millions daily face starvation. Their freedom, their independence, their socialism is still in the future.

The Real Warmakers

Only last February the leading news journals in the U.S. gave prominent space to a charge by Krishna Menon, then Defense Minister of India.

"Krishna Menon charged yesterday that the United States had tried to pull India into a war against China," said The Herald Tribune on Feb. 26, 1962. "He said he would not be a party 'to putting Indian troops where they cannot defend themselves . . . Britain and America are behind the attack on me in a big way. They are tied up so much in big business here."

Now India has been "pulled into a war against China" and Khrishna Menon has been fired as India's Defense Minister. And both these events have met the huge approval of the U.S. press.

The Mesa de Lares, united front of the Puerto Rican independentists, wishes to convey to the Security Council the truth that, contrary to what was expressed by President Kennedy yesterday (in the sense that Cuba is the first Latin American territory where nuclear weapons have been stationed) the Puerto Rican territory, which is also a Latin American territory, has been filled with atomic weapons and guided missiles, established in numerous military bases built here by the armed forces of the United States of America without the consent of our people.

This fact, publicly denounced by a group of Puerto Rican professors on September 1961, has become the most pressing source of danger to the civil population of our fatherland which suddenly finds itself in the explosive center of the Caribbean crisis without our being a part to the controversy.

While the war-mad U.S. leaders were telling the world that they were only concerned with Cuba as a military threat last month, the House Unamerican Activities Committee was attacking the Medical Aid to Cuba Committee.

The Committee's sole activity is soliciting funds to purchase medicines and medical goods for Cuba in the United States. Early in April of this year, the Committee sent approximately \$15,000 worth of medicines to Cuba.

"We Will Fight to the Last Man, Woman and Child"

The following letter was sent by Premier Fidel Castro to U Thant, Acting Secretary General of the UN, on No-

It is a historic utterance that puts into words the heroic spirit of the beleaguered, blockaded Cuban people. It will be an inspiration to the oppressed in every section of the globe, in every country and city, no matter how small.

It will be a sign to the workers of the whole world that struggle is always possible and that imperialism, no matter how powerful, can still be defied and held at bay against the day when it will be finally overcome and decisively vanquished.

... We have given you—and we have also given it publicly and repeatedlyour refusal to allow unilateral inspection by any body, national or international, on Cuban territory. In doing so we have exercised the inalienable right of every sovereign nation to settle all problems within its own territory in accordance with the will of its government and its people.

The Soviet Government carrying out its promise to Mr. Kennedy, has withdrawn its strategic missles, an action which was verified by United States officials on the high seas.

"Legitimate Self-Defense"

We should like to repeat once more that the installation of these weapons was nothing other than the act of legitimate self-defense on the part of the Republic of Cuba against the aggressive policy which the United States has been pursuing against our country since the very triumph of the Revolution.

This did not confer any right upon the Government of the United States with respect to Cuba, since all our actions have been effected within the framework of international law and in exercise of the sovereign prerogatives of our state. It was, however, the pretext used to perpetrate acts of force which brought the world to the edge of war. The pretext has now disappeared. States Government declare that they do not consider themselves bound by any promise, among other reasons because Cuba has not permitted the inspection of its territory.

The United States, resorting to the law of force, is constantly violating our territory through the use of air forces based in various parts of the Caribbean and on aircraft carriers which it is emploving against us.

"We Have Given Proof . . ."

We have given proof that we are ready for a worthy peace. We have put forward five points as guarantees, the minimum any sovereign nation can ask for. We have handed over the body of Major Anderson who died while carrying out an illegal flight over Cuban soil.

We have warned the government of the United States that it must stop these acts of violation of our sovereignty and at the same time we have done everything possible to prevent the occurrence of any incidents in connection with these acts.

What have we obtained in exchange? The violations have increased in number; every day the incursions of war. planes over our territory become more alarming; military aircraft harass our air bases, make low-level flights over our military defenses and photograph not only the dismantled strategic installations but, in fact, our entire territory foot by foot and inch by inch.

The capture of the leader of a group of spies trained by the CIA and directed by it, here in Cuba, has shown us how the photographs taken by the spying planes serve for guidance in sabotage and has also revealed, among other things, a design to cause chaos by provoking the deaths of 400 workers in one of our industries.

"But They Wish to Humiliate Us"

This impairs in its essence the security of our nation and outrages the dignity of our people. The object has been

Nevertheless, officials of the United not only to secure advantages for military and subversive purposes through information and detailed knowledge of our industrial installations and defense arrangements, but also in addition to humiliate and demoralize the Cuban

These are typically Hitlerite methods for softening the resistance of peoples.

Mr. Acting Secretary General, no sovereign state can allow its air space to be violated in this manner without feeling an impairment of its dignity. If in addition this violation is perpetrated by the reconnaissance aircraft of an enemy which openly threatens our country, tolerating it means, more than a lack of dignity, a shameful submission to the enemy. We cannot be asked to accept this by virtue of the discussions which are taking place with respect to the crisis, for the integrity of our physical space and the sovereignty of Cuba will never be negotiable.

We for our part have not failed to give constant warnings to the aggres-

"Our Right to Resist"

On Oct. 27, in the midst of the crisis, the Cuban Government declared that it would never acknowledge the vandalic and piratical privilege of any warplane to violate our air space since this was essentially a threat to our security and facilitated the conditions for a surprise attack. Cuba's right to resist such violations can never be renounced.

Today again through this communication which we are sending you as Secretary-General of the United Nations, we wish to give warning that to the extent of the fire-power of our antiaircraft weapons, any war plane which violates the sovereignty of Cuba, by invading our air space, can only do so at the risk of being destroyed.

If the United States sincerely desires—as we ourselves desire—to take steps toward the solution of the present problems, it should begin by respecting these elementary rights of our country.

In the history of our Republic, the United States has more than once interfered in our domestic affairs, with the use of force. It secured this right in the first constitution of our Republic, by virtue of a law adopted by the United States Congress and supported by an army of occupation. The present action of the United States is designed to reinstate, in fact, these militaristic and imperialist privileges.

The long history of struggle in our country, culminating in full sovereignty and national dignity after a centurylong fight written in blood and heroism, cannot be reversed.

A powerful military force could annihilate us but it could never make us yield and we should first demand a very high price of the pirates who dared invade the soil of the Cuban fatherland. And even if we should die, our banner would fly victoriously because we are defending something even more sacred than our right as a sovereign nation in the concert of free nations of the earth.

"To the Last Man, Woman and Child!"

We are sounding the necessary alarm for the defense of world peace, we are defending the right of the small countries to be considered on a footing of equality, we are telling all the peoples of the earth that before the imperialist enemy there can be no weakening. The path of calm and stern vigilance, strong in the security of a response commensurate with the magnitude of the aggression, is the only way to the salvation of

Our right to live is something which cannot be discussed by anybody.

But, if our right to live is made -conditional upon an obligation to fall to our knees, our reply once again is that we will not accept it.

We believe in the right to defend the liberty, the sovereignty and the dignity of this country, and we shall continue to exercise that right to the last man, woman and child capable of holding a weapon in this territory.

Reflections from Mae Mallory, County Jail, Cleveland, Ohio

Of Men and Dogs

A white woman I used to baby sit for when I was but a teenager once said that having me around was like having a pet-

I wondered about that statement. For it was different. The usual statement of this nature concerning a Black servant goes something like "She's just like one of the family." This time it was like having a pet around the house. The usual American household pet is a dog.

Could this woman have intended to imply that having me around the house was like having a dog around? No doubt she did! For after thinking about it and making a comparison of my life with that of a pooch's, I found out that I could not only compare very well my life with this animal but I could also contrast, with great similarity, the lives of Afro-Americans in general with those of America's most favorite household

Interestingly enough, from the comparison, I found out that it is the dog that leads the best life. Yes, perhaps the

lady was right!

About the woman: First of all, this woman lived in a very comfortable upper middleclass apartment house. You know, the apartments with "NO DOGS OR NEGROES ALLOWED." I once overheard conversations of how the landlords or management should allow dogs, but never had I heard a conversation about allowing Negroes.

Houses in the neighborhood that did allow dogs, permitted the dog to come through the front door, whether he was with his master or not. When I was without my little charge, I was instructed to use the "Service Entrance." Since I did not come to service the building, I paid no heed to such instructions and went brazenly through the front door. And no one raised a fuss! After all, a war was going on-and Afro-Americans were in it "Fighting for Democracy." Come to think of it, so were some dogs.

Many stories were told about the bravery of the K-9 dogs. Very few stories were told about the bravery of the Black men in the service. Yes, even here the dog got a better deal than the Black Soldier in the United States Army.

I have continued to make the comparison of my life with "Fido's" and find out that the dog is still ahead as we plow head-on into World War IIIalmost twenty years later.

The late Charlie Wilson once made the "dog comparison." He made a statement about preferring hunting dogs to kennel dogs-dogs that feed the master rather than those expected to be fed by the master.

Charles Wilson was once head of General Motors and that company did not hire many Negroes. What's more, those that were hired there had the most menial jobs; and they were always the last hired and the first fired. I gather that Mr. Wilson, like the lady, intended the dog comparison to be applied to Negroes

Just as there are dogs for show, there are some Negroes "for show." The master dresses these Negroes up just as he does his dog. These Blacks are put on display as Exhibit-A for the people of Africa, Asia and Latin America to see.

This Black is allowed a living wage and sometimes he is allowed to live in the same neighborhood or building with



his master. Although the master often regards this kind of home as part of his private kennel.

This show dog appears at the United Nations to vote against African independence; he shows up in Africa, Asia, and Latin America as diplomats and ambassadors with portfolio; but with lots of foolish propaganda on how well the Black man is treated in America and the "progress we are making." Dogs are never made to stoop this low. For never have I heard of a dog having to propagandize other dogs as to the benevolence of his master.

Most Negroes do not choose to lead a dog's life-whether it is a lap dog, hunting dog, or one from the kennel. They do not want scraps from the master's table, neither crumbs; neither do we choose to be masters-only masters of

The thinking Black man in America realizes that he needs liberation. We live in shacks that no self-respecting dog would appreciate. We are unemployed many months of the year, and there is admittedly no relief in sight from this situation. We cannot afford proper medical care; our infant mortality rate is much higher than the White citizens in America. We still fill the jails and hang on trees until we are dead. Our bodies are still found in bags weighted with concrete at the bottom of rivers. Our arms, heads and legs are still being severed from our bodies. And we are still being found in rivers-no water in our lungs-dead. These deaths are always "accidential, heart attacks, or of natural causes. No investigations needed."

These things shouldn't happen to a dog. But they do happen to Negroes in

Just recently, I read of the case of a dog fighting for his life in the courts. This dog is accused of killing six sheep. For this the courts have ordered him to be put to death. The case is now before the Supreme Court. Chances are that this dog will be allowed to remain in his home pending the outcome of litigation,

I, too, have a case before the United States Supreme Court. But look where have to stay pending the outcome of litigation. For many months, I have been locked up in the Cuyahoga County Jail; denied the companionship of my family and friends. This dog is actually accused of killing six sheep. I killed no one. I am guilty of no crime. But this dog will probably get more consideration from the courts than I will.

Certainly so; for in every court action since March first, the courts have ruled against me, denied me bond, taken away my right to walk the streets and talk with my children. I am treated like the most dangerous felon society can imagine. This shouldn't happen to a dog!

It is also said that Charles Wilson once remarked "What's good for General Motors is good for the Nation." A true spokesman of the American Government could certainly be safe in saying that what is good for our dogs is too good for our Negroes.

But You Need a Microscope to Find the Story in the Newspapers

They Robbed Us of \$8 Billion for "Strategic" Boondoggling!

The exposure of one of the very biggest financial scandals in history is proceeding at a leisurely pace with subdued and modest headlines and no harsh words at all for the crooked billionaires responsible. This is the "stockpile" scandal.

It was none other than John F. Kennedy himself, who on January 31 of this year, revealed that the U.S. stockpiling of "strategic" materials was an outright waste of the taxpayers' money.

'The total stockpile now amounts to \$8.7 billion worth of material.... It exceeds our present emergency requirements by nearly \$3.4 billion."

(This was interesting news in view of Eisenhower's having invoked the Taft-Hartley Act against striking steelworkers in 1959. A government injunction made them go back to work because the lack of steel was termed a , 'national emergency." But steel in the government stockpiles was coming out of the nation's collective ears. Where was the "emergency"?)

"In some cases," Kennedy said, "the government has acquired more than seven times the amount that could possibly be used (in the event of war)."

"For example," he added, "the value of the aluminum in this stockpile exceeds the amounts we would need for three years' war by \$347 million. The excess supply of nickel

is \$103 million." **Great Progress!**

This was on the 31st of January. A big investigation was ordered. But by May, the cost value of the stockpile had increased by \$16,352,304.

Kennedy was of course "sincere" about cutting down on the stockpile expense, if only to have more money available to buy rockets and nuclear bombs. But he was stepping on some very big toes, and he knew it. The fanfare of his first attack, however, was meant to discomfort his Republican opponents who had negotiated these lush contracts more than it was meant to imprison or disgrace the big money men who profited most from them.

And Kennedy has since discovered that not just a few billionaires and a few government crooks are involved, but the whole capitalist system itself.

"Set a Thief . . ."

Take for example the case of the man whom he put in charge of the subsequent investigation-Senator Stuart Symington of Missouri.

In the middle of June, right while Symington was in a "fight" to stop the useless stockpiling of lead and zinc, he was also busy pushing a law through the Senate to "stabilize" lead and zinc prices with several millions of dollars worth of subsidies to the big mine owners (some in Symington's home state of Missouri).

Symington said at the time that he could "see no inconsistency" in his investigation of the government buying too much lead and zinc for stockpiling and at the same time his voting for the government to pay out still more money to the mine owners.

One week after Symington's subsidy plans hit the press, a government official (of the Office of Emergency Planning), Mr. William N. Lawrence, revealed that there was a surplus of \$200 million worth of lead and zinc in the government stock-

Mr. Lawrence revealed to Symington's committee that the lead and zinc had in reality been bought not in the interest of strategic stockpiling, but with the sole purpose of keeping prices high.

Since Symington himself is also interested in keeping lead and zinc prices high, it is hardly surprising that he has done little about this matter since his investigation. (He resumed his investigation this month.)

They Robbed the Taxpayers

Senator Symington has of course turned up some scandalous robberies of the government in his investigations.

The American Chrome Company made annual profits of 400 per cent on a contract for low grade chromite ore. The Miami Copper Co., the Copper Range Co., Howe Sound Co. and Banner Mining

Co. got unwarranted profits of \$650,000 without investing a dime. American Aluminum, Reynolds Aluminum, U. S. Steel, Bethlehem Steel, etc., etc., made hundreds of millions,

Who is to blame?

A whole series of government clerks and minor officials have been indicted for taking a few thousand dollars or for taking jobs in companies that were negotiating with the government. But the really big fish-the sharks behind the above companies-remain uncaught.

Cuba Saved You Money!

The only real saving to the U.S. worker-taxpayers was achieved not by Kennedy, not by Symington, but by revolutionary Cuba.

Yes, Cuba saved the U.S. government from spending \$248 milliin on unneeded nickel. It did this-unknowinglyit seized the Cuban-American Nickel Company's mines and plants in 1960. Cuban-American Nickel could not deliver the nickel to the U.S. because it no longer owned its plants. So the government was able to cancel the contract. John Hay Whitney, chairman of the

board of Freeport Sulphur (which happens to be the parent company of Cuban-American Nickel), before he became U.S. Ambassador to Britain, had negotiated a contract to supply the government with nickel at 74 cents a poundthe highest price of nickel in the preceding 28 years.

(The contract provided that if the price of nickel went above 74 cents, the government would pay the higher price. If it went below 74 cents, the government still had to pay 74 cents—some contract!)

And remember that according to Kennedy, there was an excess supply of nickel amounting to \$103 million without any nickel from John Hay Whitney.

But the best laid plans of John Hay Whitney and Freeport Sulphur went astray-due to the Cuban revolution. Unfortunately, that is not true of the plans of the Morgans, Mellons, Duponts, Phelps Dodges, etc., who own the steel, aluminum, chemicals, copper, etc., in-

While the U.S. worker-taxpayers have forked over billions of dollars to keep big business making money at jet speed, what about the stockpile itself? Is it fulfilling any function of national "defense" at all-even assuming that imperialist war is meant to defend people rather than slaughter them?

Not according to Harlan P. Bramble. deputy director of the Office of International Resources. He said on July 2 that the stockpiles are not needed.. in a "Korean-type of brush-fire war" and "would be useless in a nuclear-type war"!

Taxpayers' investment in the stockpiles, he said, must be written off. He added that attempts to sell substantial amounts would only wreck world mar-

So between Kennedy's mighty capitalist friends, Symington's not-so-penniless backers, and the whole irrational capitalist system itself, there's going to be about nine billion dollars worth of nickel, iron, steel, copper, cobalt, graphite manganese, industrial diamonds and almost anything else you can think of, rusting, corroding, leaking, decaying and wasting away.

Couldn't YOU Use It?

And think of the schools and hospitals that could be built with \$9 billion. Think of the parks and swimming pools. It's enough to build a brand new home for every sharecropping and tenant farmer in the South and have more left over than the government has spent on education, health and welfare for years.

It's nine times the amount of wealth that all U.S. companies used to "own" in Cuba.

It's over three times the amount of the combined annual income of all the Cuban

It's enough to give every single Afro-American family in the U.S. \$2,000 in

But it just sits there. It's no good for war, and it would "wreck the market" in peace.

Couldn't you think of something to do

with it?
